
NEVADA NOXIOUS WEED STATUTES NRS 555

- NRS 555.150 Every landowner or occupier, whether private, city, county, or federal shall control all noxious weeds.
- NRS 555.160 The State Quarantine Officer may serve notice upon the owner or occupant to control noxious weeds on their property.
 - In this notice the NDA Noxious Weed Program specifies which noxious weeds are present, effective control measures, and required time range for controls to be completed to gain compliance with statutes
- NRS 555.170 Should the owner/occupant fail to comply, the State Quarantine Officer may notify the board of county commissioners for the county in which the property is situated.
 - The county board of commissioners shall proceed to have weeds controlled in accordance with the initial notice.
- NRS 555.180 Control costs not paid by the owner shall be a lien against the property and shall be collected as provided by the law

CREATION OF WEED DISTRICT NRS 555.202

- NRS 555.202 "The Legislature...finds that in certain areas the responsibly to control weeds can best be discharged through control by organized districts"
- NRS 555.203 The Board of County Commissioners may create one or more weed control districts and shall appoint a board of directors of the district.

The weed district assumes same authority as state for noxious weed statutes enforcement and may, by resolution of the board of county commissioners, levy an assessment upon all real property in the county which is in the weed district to provide funding for the control of weeds.






STATEWIDE NOXIOUS WEED ACTIVITIES



CARSON NOXIOUS WEED CONTROL NEEDS FOR 2015 AND BEYOND

- 1. Dedicated Carson City Weeds Coordinator position
- 2. Allocation of funds specifically to noxious weeds
 - Currently Parks, Open Space, and Public Works all individually allocate some funding from overall budget to weeds.
- Revival of local level coordination across property boundaries to achieve landscape level treatments, containment, and control of noxious weeds infestations

FUTURE NDA ACTIVITIES AND SUPPORT

- 1. Receive and respond to complaints; increase in regulatory pressures to neighboring landowners
- 2. Survey and mapping for new infestations or project areas
- 3. Trainings and education/outreach
- 4. Availability of grant funds to support coordinator position and/or on the ground work to be completed
