report for 2014/15 and work plan for 2015/16.

#### General Discussion:

The Cultural Commission is required by Carson City Municipal Code (CCMC) 2.41.060 (7) to submit an annual report and work plan to the Board of Supervisors no Later than May 1st of each year. The Parks and Recreation Department has developed the below list of items the Cultural Commission has worked on from May 2014, to the present for the Commission's 2014/15 annual report to the Board of Supervisors. In addition, staff has taken the liberty to developed a number of initiatives for the Commission's consideration for its 2015/16 work plan. City staff is seeking comments from the Commission on these items before submitting a finalized annual report and work plan to the Board of Supervisors for approval.

The following is a list of items that the Cultural Commission worked on from May 2014, to present.

- 1) On June 17, 2014, the Commission arranged a walking tour to review the City of Reno's indoor public art collection and outdoor public art in the downtown area with Ms. Christine A. Fey, AICP Resource Development & Culture Affairs Manager.
- 2) On September 16, 2014, the Cultural Commission and Historic Resources Commission held a joint meeting to hear a presentation on Nevada State Prison Steering Committee's final DRAFT report for the Nevada State Legislature entitled "The Future of the Nevada State Prison" pursuant to Assembly Bill 356.
- 3) On December 16, 2014, the Commission recommended to the Board of Supervisors that the Cultural Commission pursues the development of a Cultural Master Plan for Carson City and take the lead on developing a scope of work and funding implementation strategy for the Cultural Master Plan, including seeking Nevada Art Council grants and other grant funding opportunities. (This recommendation has not been taken to the Board of Supervisors by City staff at this time.)
- 4) On March 15, 2015 The Commission addressed the following issues:
  - A. Approved the final graphic designs for City street banners as a part of the Carson City Visitors Bureau's "The Experience Starts Here" marketing campaign.
  - B. Recommended to the Board of Supervisors to use the Carson City Arts Assessment (A Current Reflection of the Arts /Dated June 2001) and the Creative Capital (Carson City Community Arts Plan / Dated February 2002) as the basis for pursuing the development of a Cultural Master Plan for Carson City.

C. Listened to a presentation on the future plans for the Stewart Indian School's Cultural Center and Welcome Center by Ms. Sherry L. Rupert, Executive Director of the Nevada Indian Commission.

Also, during the past year the Commission continued to support community arts and culture in the following manner:

- 1) There was an increase in constructive communication and Committee/City staff liaison activities with the following organizations.
  - A. Carson City Arts and Culture Coalition
  - B. Brewery Arts Center
  - C. Carson City Arts Initiative (CCAI)
  - D. International Film Festival
- 2) The Commission reported on and actively supported a number of arts and cultural events including:
  - A. Greenhouse Project
  - B. State of Nevada's Sesquicentennial (Nevada 150) Celebration
  - C. Fulstone Wetlands Mural Project
  - D. CCAI's Art Exhibition Venue in the Community Center's Sierra Room
  - E. Downtown "Refresh" Project for Carson Street, Curry Street, and Street.

The Cultural Commission anticipates the following initiatives for its 2015/16 work plan and is seek Board of Supervisors approval on the below task prior to moving forward with these projects.

- Pursue the development of a Cultural Master Plan for Carson City using the Carson City Arts Assessment and the Creative Capital documents as the basis for pursuing the development of a Cultural Master Plan and take the lead on developing a scope of work and funding implementation strategy for the Cultural Master Plan, including seeking Nevada Art Council grants and other grant funding opportunities.
- Make recommendations to the Board of Supervisors on funding for various arts and culture events using Redevelopment Authority funds.
- Coordinate a grant application process with Community Development / Planning Division for using Redevelopment Authority Funds to award arts and cultural grant for events.
- Continue to support efforts to preserve the decommissioned Nevada State Prison as a historic place and possibly a museum.
- 5) Support the State of Nevada efforts to create the Stewart Indian School's Cultural Center and Welcome Center.
- 6) Continue to provide a public forum for discussions and partnership building with various community organizations on community art and culture issues and/or upcoming art and culture events.
- 7) Reach out to Carson High School's AP Art Class for future senior mural projects.

City staff has provided the Commission with last year's approved Board of Supervisors annual report and work plan dated April 17, 2014 (Exhibit A) and the Cultural Commission's 2014 meeting index (Exhibit B).

These documents are being provided to the Commission as reference materials to assist in the development of the 2014/15 annual report and 2015/16 work plan.

In addition to the above information, CCMC 2.41.060 (7) requires that Commission members attendance records be included as part of the annual report to the Board of Supervisors.

Cultural Commission's 2013/14 Annual Report and 2014/15 Work Plan (Exhibit A)

The Cultural Commission is required by Carson City Municipal Code (CCMC) 2.41.060 (7) to submit an annual report and work plan to the Board of Supervisors no later than May 1 of each year.

The following is a list of items worked on by the Cultural Commission from May 2013 through March 2014.

- 1) The Commission presented a Public Art Program Ordinance to the Board of Supervisors on September 5, 2013. The Board rejected on a 2 to 3 vote the Cultural Commission's proposed amendments to the Carson City Municipal Code, Title 2, Chapter 2.41 and requested the Commission return at a future date with a new funding mechanism for the Public Art Program.
- The Board of Supervisors approved the Commission's mission statement and meeting bylaws with a few minor changes, on August 1, 2013.
- On June 18, 2013, the Commission recommended to the Board of Supervisors to support art and cultural components in the Carson City Downtown 20/20 Action Group's plan for downtown revitalization.
- 4) The Commission reported on and supported several arts and cultural events including:
  - A. Nevada Academy for the Performing Arts
  - B. Greenhouse Project
  - C. State of Nevada's Sesquicentennial (Nevada 150) Celebration
- 5) There was an increase in constructive communication and liaison activities between the Cultural Commission and the Carson City Arts and Culture Coalition.
- 6) The Commission reviewed and approved the Carson City Visitor Bureau's banner designs for Fairview Drive based on their "The Experience Starts Here" marketing message that would include various images of the City's arts/cultural events, activities, and experiences instead of using the existing streetlight poles along Fairview Drive for either a location of public art or replacing the old cultural banners.
- 7) The Commission discussed possible ideas to honor Jeffery Scott, Former Commission Chairperson, upon passage of the Public Art Program Ordinance.
