CALL TO ORDER, ROLL CALL, INVOCATION, AND PLEDGE OF ALLEGIANCE: Mayor Teixeira called the meeting to order at 7:20 A.M. Clerk-Recorder Alan Glover took the roll and a quorum was determined present. Samuel Caldwell gave the invocation and Mayor Teixeira led the Pledge of Allegiance.

Mayor Teixeira recessed the meeting at 7:25 A.M. and reconvened at 7:45 A.M.

Mayor Teixeira reviewed the interview process and table assignments. Each of the seven applicants, Ann Silver, George Weeks, John Berkich, Dennis McDuffie, Robert Jasper, Michael Rody, and Miles Crafton, was given the opportunity to briefly address the assembly, introduce themselves and provide a brief summary of their qualifications for the position of City Manager.

Mayor Teixeira recessed the meeting at 8:20 A.M. and reconvened at 8:45 A.M.

The assemblage was then divided into their seven table assignments and the interviews progressed. After approximately twenty minutes at each table, the applicants were instructed to rotate to the next table until each applicant had visited each of the seven tables.

The applicants answered questions regarding their residency, qualifications and abilities, past work history, what their main objectives would be for Carson City, how they would handle various situations that might arise in City operations and other related questions.

Mayor Teixeira closed the table discussions at 11:10 A.M. and reviewed the order and time schedule of the afternoon session with the Board of Supervisors. The City Manager Selection Rating Form was collected from each participant to be delivered to the Board of Supervisors following their interview session. The meeting was adjourned at 11:30 A.M.
