Agenda Title: For Possible Action: To authorize the Mayor to sign a letter of support for the Dangberg Home Ranch Conservation Easement located in Douglas County, Nevada, for consideration in Round 16 of the Southern Nevada Public Land Management Act grant program - Environmentally Sensitive Land Acquisition category.

Staff Summary: The Dangberg Home Ranch Conservation Easement will protect 2,835+/- acres owned by Park Ranch Holdings, LLC. This property surrounds the Dangberg Home Ranch Historic Park, formerly a State Park, and will include a donation to the public of an additional 32-acre river park. Legacy Land and Water, LLC is the applicant on behalf of the landowner and the Bureau of Land Management would hold the conservation easment. Carson City is not eligible to submit a funding request under this category.

Background/Issues & Analysis

The Southern Nevada Public Lands Management Act (SNPLMA) became law in October 1998. It allows the Bureau of Land Management to sell public land in southern Nevada with some of the revenue derived from land sales being used for environmentally sensitive land acquisitions and conservation easements. Nominations are open for Round 16.

The Dangberg Home Ranch consists of irrigated pastures, wet meadows, wetlands, and riparian habitat along 3.75 miles of the East Fork of the Carson River. The Dangberg Home Ranch Conservation Easement will create a vast expanse of unfragmented open space and agricultural land critical to the natural floodplain functions that protect local and downstream communities, including Carson City. In flood events, and even in normal runoff periods, the Dangberg Home Ranch allows both the East and West Forks of the Carson River to leave its normal channel and attenuate the flow into Carson City. This reduces the peak flow downstream, and releases water over a longer time period than if it simply "flashed" through the Carson Valley. Maybe even more importantly this ranch is critical to the groundwater recharge of the region, and helps create a sustainable water supply



The Dangberg Home Ranch brings to life the history of one of Nevada's great pioneers, H.F. Dangberg, who first arrived in Nevada in 1853 to pan for gold. By 1856, Dangberg made his first land claim in the heart of Carson Valley, the beginning of what would become an agricultural and livestock operation stretching from Alpine County, California, to Carson City, Nevada. The Dangbergs played a significant role in Carson Valley's development. Whether bringing the Virginia and Truckee Railroad into the Carson Valley, founding The Town of Minden, or the inaugural Carson Valley Days, the Dangberg Home Ranch is where it all began.

Today, Dangberg descendants continue to manage the Dangberg Home Ranch as a ranching and agricultural operation. In addition to the culture, history, and lore of Carson Valley, the Dangberg Home Ranch exhibits tremendous agricultural and natural resource values. The Dangberg Home Ranch consists of irrigated pastures, wet meadows, wetlands, and riparian habitat along 3.75 miles of the East Fork of the Carson River, from Minden nearly to Genoa. With one fell swoop, the Dangberg Home Ranch Conservation Easement will forever protect 2,835 acres of prime agricultural and floodplain lands that are critical to protecting Carson Valley residents and other downstream communities during flood events. The Dangberg Home Ranch connects with other existing conservation easements to create a vast unfragmented expanse of open space and agricultural land. The owner will provide a multi-use trail easement to help connect the towns of Minden and Genoa, and will donate a public 32-acre river front park. The Dangberg Home Ranch Conservation Easement will protect the natural resources, quality of life, and rural character of Douglas County, and ensure its continued economic agricultural viability.


