The Board of Supervisors authorized the funding on May 5, 2016 and approved it with the City budget.

Previous Action

On January 7, 2016 the Board of Supervisors approved the Community Support Services Grant (CSSG) noncompetitive funding. On May 5, 2016 the Board of Supervisors approved the CSSG competitive funding for FY2016-17.

Background/Issues & Analysis

In total, the CSSG program will award \$260,000 from the General Fund to non-profit organizations that address a critical need in Carson City. In addition, \$120,000 will be awarded to the Boys and Girls Club of Western Nevada from the Quality of Life Initiative.

A RESOLUTION AUTHORIZING EXPENDITURES OF FUNDS TO NON-PROFIT ORGANIZATIONS FOR FY 2016-17

WHEREAS, NRS 244.1505(1) provides that the Board of Supervisors may grant money to private organizations, not for profit; and

WHEREAS, NRS 244.1505(2) provides that such grants must be made by a resolution which specifies the purpose of the grant, the maximum amount to be expended from the grant and any other conditions upon the expenditure; and

WHEREAS, the Board of Supervisors has conducted public hearings, taken testimony and received evidence of the substantial benefit to the inhabitants of Carson City of the expenditure of money for grants to the private organizations, not for profit, which are listed below.

NOW, THEREFORE THE BOARD OF SUPERVISORS RESOLVES THAT:
