**Staff Summary:** All liquor license requests are to be reviewed by the Liquor and Entertainment Board per CCMC 4.13. Hohl Motorsports, Inc. is applying for a bar liquor license. Applicant has met the requirements per CCMC 4.13.125 and staff is recommending approval.

# **Proposed Motion**

I move to approve Timothy Hohl as the liquor manager for Hohl Motorsports, Inc. dba Battle Born Harley-Davidson (Liquor License #16-31418), located at 2900 Research Way subject to the following conditions 1. The applicants and all employees serving alcohol must complete a server training course acceptable to the Sheriff's Office within 120 days of obtaining a license, pursuant to CCMC 4.13.060, 2. With the exceptions listed in CCMC 4.13.240(5), liquor is to be served and sold during special events only, 3. No permanent day to day sales of packaged beer, wine, or hard liquor, 4. Alcoholic beverages are served in their original container or in disposable cups, and 5. Sales of hard liquor that include the use of ice, a temporary health permit must be applied for 5 days prior to the event

# **Background/Issues & Analysis**

The business was closed in November 2015, and purchased by Hohl Motorsports in February 2016. The intent of applying for a permanent liquor license is for the ability to serve liquor during special events instead of applying for special event liquor permits. Battle Born Harley-Davidson is anticipating 10-20 special events during the course of a year, to include, but not limited to poker runs, rallies, and Street Vibrations. Issuing a permanent liquor license to Battle Born Harley-Davidson instead of a special event liquor permit will provide a continual point of contact for the sales and service of liquor, and require all employess to attend an alcohol server training course. However, a permanent liquor license does not exempt Battle Born Harley-Davidson from the special event permitting process.

On June 1, 2016 an evaluation of the application by Hohl Motorsports, DBA-Battle Born Harley Davidson, located at 2900 Research Way, for a Dining room with hard liquor was reviewed.

This establishment does not meet any applicable standards for a Dining room with hard liquor sales on a permanent basis as set forth in Nevada Administrative Code 446.

However, our approval is based on the following conditions being met:

- NO PERMANENT day to day sales of packaged beer, wine or hard liquor occurs.
- Sales of package beer, wine or hard liquor ONLY occur at special events.
- Alcoholic beverages are served in their original container or in disposable cups.
- Sales of hard liquor that include the use of ice, a temporary health permit must be applied for five (5) days prior to the event.
