#### 3. MEETING ITEMS

# A. INTRODUCTION OF JENNIFER BUDGE AS THE NEW CARSON CITY PARKS AND RECREATION DIRECTOR.

(5:38:19) – Chairperson Bugli introduced the item. Vern Krahn introduced newly-hired Parks and Recreation Director, Jennifer Budge, per the Staff Report incorporated into the record. Ms. Budge gave background on her education and past experience in Washoe County, referencing the attached agenda materials.

There were no public comments.

### B. INTRODUCTION OF CLAUDIA VECCHIO AS THE NEW NEVADA DEPARTMENT OF TOURISM AND CULTURAL AFFAIRS MEMBER TO THE CULTURAL COMMISSION.

(5:39:37) – Chairperson Bugli introduced the item. Mr. Krahn presented the Staff Report which is incorporated into the record, and noted that Claudia Vecchio, Director of the Nevada Department of Tourism and Cultural Affairs, will replace Commissioner Peter Barton. Commissioner Vecchio expressed her thanks and stated that she was looking forward to a partnership with the Commission and the Carson City Visitors Bureau. Vice Chair McBride believed that Commissioner Vecchio's tourism link would be "really useful, and I look forward to tapping into your experience to help the overall mission of the Commission".

# C. PRESENTATION AND DISCUSSION ONLY ON THE DOWNTOWN 20/20'S GATEWAY ENTRANCE ARCHES PROJECT INTO DOWNTOWN CARSON CITY.

(5:41:37) – Chairperson Bugli introduced the item. Doreen Mack, President of the Downtown 20/20 Group, gave background and introduced Sam Flakus and Matt Schilling, the artists who will design the Carson City entrance arches. Mr. Flakus and Mr. Schilling presented the agenda materials which included the design concepts and proposed materials. They also answered clarifying questions. Commissioner Abowd was informed by Mr. Krahn that the soon-to-be-hired arts and culture coordinator would be involved in the project once the policies and procedures were put in place. Commissioner D'Anneo cautioned against low arches that may prevent Nevada Day Parade and Burning Man vehicles from going under them. She also encouraged getting the information to the public, calling the design "gorgeous". Chairperson Bugli ensured that any plan would be subject to public input. Commissioner Vecchio suggested having a formal proposal to satisfy grant and other funding

requirements. Commissioner Cook inquired about the arch strength to hold banners; however the consensus was not to have banners any longer. Ms. Budge advised that the Commission refrain from any suggestions for action as the item was agendized for discussion only.

#### PUBLIC COMMENT

(6:10:09) – Gloria Dyla introduced herself as a member of the Downtown 20/20 group and noted that seed money and grant matches were needed by the group.

### D. DISCUSSION ONLY ON THE CARSON CITY ARTS AND CULTURE COALITION'S FENCE PROJECT LOCATED AT CURRY AND TELEGRAPH STREETS.

(6:11:55) – Chairperson Bugli introduced the item. Carson City Arts and Culture Coalition's Cindy Brenneman introduced herself and presented the agenda materials. She reported on the "Focus on Carson" photography contest, incorporated into the record, and noted that the banner featuring the entries will be hung on June 22, 2016, at 10:30 a.m., on the construction fence at Telegraph and Curry Streets. Ms. Brenneman also answered several clarifying questions. Vice Chair McBride was informed that the banner cost around \$1,000.

(6:18:03) – Chairperson Bugli introduced the item. Joel Dunn, Executive Director of the Carson City Visitors Bureau, introduced himself and gave background. Mr. Krahn presented the Staff Report, incorporated into the record, for approval by the Commission. Discussion ensued regarding the removal of the mammoth image because of overuse. Commissioner D'Anneo believed the images were dark and suggested adding images of children. Commissioner Abowd proposed adding images of theater productions.

(6:28:46) – Chairperson Bugli introduced the item. Mr. Dunn gave a status update, incorporated into the record, on the recruitment efforts, highlighting that there were many national and international applicants. He also outlined the upcoming and interviewing process and stated that he planned to fly in the top applicants for panel interviews. Mr. Dunn stated that he planned to utilize the available City resources, through interlocal agreements, for grant writing, RFQs, and RFPs should the coordinator not possess those skills.

### G. FOR POSSIBLE ACTION: TO SCHEDULE A COMMISSION TOUR OF THE STEWART INDIAN SCHOOL.

#### 4. STAFF UPDATES - DISCUSSION ONLY

# A. Update on the Redevelopment Authority's action to fund \$24,000 in arts and culture special events for fiscal year 2016/17.

(6:40:29) – Mr. Krahn reported that in May, 2016 the funding for La Ka Lel Be Pow Wow recommended by the Commission for funding by the Redevelopment Authority (RA) had been denied because the event was not being held in a Redevelopment District. Commissioner Abowd expressed her disappointment and noted that she had requested that, moving forward, all applicants be present to answer questions during the RA meetings. Mr. Krahn stated that he had been able to put the applicants in touch with the Community Center staff to see if they could accommodate the Pow Wow event in the Community Center for Nevada Day. He believed that the RA could reverse its decision should the venue change. Vice Chairperson McBride received confirmation that the \$6,000 allocation had not been redistributed among the other applicants. Discussion ensued regarding the role of the RA once the fund allocation recommendation had been moved to the Commission. Commissioner Abowd recommended agendizing the item for discussion between the Redevelopment Authority Citizens Committee and the Cultural Commission.

### **PUBLIC COMMENT**

(6:47:33) – Mr. Dunn informed the Commission that the Visitors Bureau would be working closely with Mr. Montgomery (Pow Wow organizer) to provide social media and marketing assistance. He also clarified that if the event is endorsed by the Bureau, it will be eligible for room tax funds to cover event costs.

### 5. MEMBERS' ANNOUNCEMENTS AND REQUESTS FOR INFORMATION

### A. CULTURAL COMMISSION MEMBERS' STATUS REPORTS ON PROJECTS AND COMMENTS.

### 1. UPDATE ON THE GREENHOUSE PROJECT.

(6:49:09) – Commissioner Abowd noted that general admission and bleacher seat tickets for the July 14, 2016 Concert Under the Stars, featuring Tower of Power, were available online only, as Adele's was almost sold out of its tickets. She also thanked the sponsors of the concert.

### 2. UPDATE ON THE STEWART INDIAN SCHOOL'S CULTURAL CENTER.

(6:52:31) – Chairperson Bugli informed the Commission that the utility box painting project had been stalled due to the difficulty in obtaining certain permissions.

(6:54:08) – Chairperson Bugli referred to the list of future agenda items incorporated into the record. Commissioner Abowd inquired about the public art document being reviewed by the District Attorney's Office and Ms. Yowell confirmed that the review was in progress.

### 4. PUBLIC COMMENTS

(6:55:07) – Gina Hill, Brewery Arts (BAC) Center Executive Director, reported on the success of the Levitt Amp Outdoor Concert Series. She also updated the Commission on the art wall provided for the public to paint and invited the Commissioners to see it prior to it being painted again to be used the following week. Ms. Hill announced the building of "Harmony Sculpture Park" in the plaza area on the BAC to feature "useable, workable musical instruments" for public use and hoped that the project would be completed in July.

(6:58:12) – Mr. Dunn explained that any future agenda items should be requested through the Visitors Bureau moving forward, as they would be coordinating the upcoming Cultural Commission meetings.

(6:59:01) – Vice Chair McBride reported on the Arts at the Heart conference and believed a Northern Nevada Arts Coalition to create cooperative projects between Northern Nevada cities such as Reno, Carson City, Virginia City, etc. would be beneficial.

(7:02:02) – MOTION: Vice Chair McBride moved to adjourn. The motion was seconded by Commissioner **D'Anneo.** The meeting was adjourned at 7:02 p.m.
