**Subject Title:** Action to accept Public Works recommendation and award the "Carson City Freeway Phase 2A Utility Relocations, Colorado St., Saliman Rd., and Fairview Dr. /Linear Ditch Project, Contract No. 2006-074 to the lowest responsive and responsible bidder pursuant to the requirements of NRS 332, 338, 339 and 624 for a total contract amount of the lowest bid plus 10% construction contingency from the Water and Sewer NDOT By-Pass Funds as provided for in FY 2006/2007.

**Staff Summary:** Carson City is in the process of relocating their facilities as part of the Carson City Freeway Phase 2A Utility Relocations Project and the above described contract is necessary for construction and relocations on Colorado St., S. Saliman Rd., and Fairview Dr. to Linear Ditch along the Freeway corridor. Because of critical time constraints for completion of this work, the bid opening was scheduled for November 30, 2006. The results of the bid opening will be made available to the Board of Supervisors at the Board meeting of December 7, 2006.

**Recommended Board Action:** I move to accept Public Works recommendation and award the "Carson City Freeway Phase 2A Utility Relocations, Colorado St., Saliman Rd., and Fairview Dr. /Linear Ditch Project, Contract No. 2006-074 to the lowest responsive and responsible bidder pursuant to the requirements of NRS 332,338, 339 and 624 for a total contract amount of the lowest bid plus 10% construction contingency from the Water and Sewer NDOT By-Pass Funds as provided for in FY 2006/2007.

Explanation for Recommended Board Action: This project was formally bid following the guidelines of NRS as indicated below. The recommendation above is to the lowest responsive and responsible bidder pursuant to those guidelines. This contract will provide for construction related to the City sewer and water relocations for Phase 2A of the Carson City Freeway in the Colorado St., S. Saliman Rd., and Fairview Dr. /Linear Ditch area. This contract has a very tight schedule in order to relocate major sewer collection and water transmission lines and not delay NDOT's freeway contractor. The Bid opening is scheduled for 2:10 p.m., November 30, 2006, and the engineer's estimate of construction is \$2,254,752.00. The Colorado St, S. Saliman Rd., and Fairview Dr. /Linear Ditch area sewer and water relocation is one of three relocation projects related to Phase 2A of the Freeway. Construction in the area is expected to begin January, 2007. The Board of Supervisors approved the reimbursement agreement with NDOT for this work at its October 5, 2006, meeting. Additional relocation projects will be performed in the Fifth St. /Butti Way area and along Highway 50 East on both sides of the Freeway.
