**Petition to Nevada State Legislature**  
**Assembly Committee on Government**  
**Regarding AB140 Requested by Assemblyman Kramer**  
**Revises the boundary line between Carson City and Washoe County**

<p><b>Petition summary and background</b></p>	<p>We support the change due to current inadequate emergency services, closer proximity to Carson City community services and shopping, and our daily participation in Carson City civic and social activities.</p> <p>Multiple occurrences of inadequate responses to 911 emergencies have occurred. There have been three recent requests for emergency medical transportation with no response from REMSA. In one case a volunteer paramedic from Washoe Valley responded and when REMSA Emergency Transportation did not respond the volunteer assisted in loading the stroke victim in a private vehicle for transport to the hospital. Another resident was a victim of a burglary ring with initial Washoe County Sheriff response time near one hour. The crime was solved by the Carson City Sheriff. There are no examples of timely emergency services by Washoe County.</p> <p>The following are examples of the distance to Carson City Community Services as compared to Washoe County:</p> <ul style="list-style-type: none"> <li>&gt; Carson Tahoe Hospital 3.5 miles / Renown 25.5 miles</li> <li>&gt; Carson City Community Center 6.5 miles Neil Road (closest Washoe County) Recreation Center 23 miles</li> <li>&gt; Public schools Carson City Elementary School 5 miles / Washoe County Pleasant Valley 12 miles Carson Middle School 6 miles / Washoe County Dapoali 19 miles (2 1/2 hour ride on school bus) Carson High School 6 miles / Washoe County Damonte 19 miles</li> <li>&gt; Carson City Public Library 6.8/ South Valleys Library 17 miles (A state library card is accepted by the Carson Library, but not by Washoe County Libraries.)</li> </ul> <p>We socialize, shop, and support Carson City community services. While emergency services may never be needed we believe Carson City will provide for time sensitive services when needed. This change will link us to our local municipality.</p>
<p><b>Action petitioned for</b></p>	<p>We, the undersigned, are concerned citizens who urge our leaders to act now and approve AB 140 moving the residents and the property owner's of Duck Hill from Washoe County to Carson County.</p>
