Previous Action

Carson City Board of Supervisors declared a local disaster from the period January 5th through January 14th, 2017, due to an impending winter storm and flooding. (Resolution no. 2017-R-2)

Background/Issues & Analysis

Due to damages sustained during the flood event of January 2017, Carson City is working with Nevada State Division of Emergency Management and FEMA. A State Declaration was also made and the Disaster was declared by the President of the United States on February 17, 2017. Carson City has submitted its application for Public Assistance to the Division of Emergency Management and further asks the Board of Supervisors to approve our intent to apply for assistance from the Nevada State Disaster Relief account.

Applicable Statute, Code, Policy, Rule or Regulation

A Notice of Intent form needs to be completed in conjunction with an accompanying cover letter and submitted to the Division of Emergency Management (DEM), per NRS 353.2755, not later than 60 days after the governing body of a local government determines that an event constitutes a disaster, a local government may submit to the Division a written notice of the local government's intention to request a grant or loan from the State Disaster Relief Account (DRA).
