Agenda Title: For Possible Action: To approve the purchase of Nexplanon (a long acting birth control implant) for Carson City Health and Human Services (CCHHS) through the 340B/Prime Vendor Drug Discount Program, a U.S. federal government program, from Curascript, an approved distributor under this program, for a total amount not to exceed \$61,500.00 to be funded from the Health and Human Services Clinic Title X account for FY 2016/2017. Staff Summary: The Carson City Health and Human Services Department utilizes the current 340B/Prime Vendor Drug Discount Program to purchase Nexplanon, a long acting birth control implant, for clinic family planning patients under the Title X (Family Planning) program.

Background/Issues & Analysis

CCHHS recently received additional Title X funding that needs to be spent by March 31, 2017 and has been approved for Nexplanon purchases. At the beginning of the fiscal year, CCHHS was unaware of the additional funding and had no intention of purchasing more than \$50,000 from Curascript.

Applicable Statute, Code, Policy, Rule or Regulation

NRS 332.115 and NRS 332.195. This purchase is excepted from competitive bidding under NRS 332.115(m) "supplies, materials or equipment that are available pursuant to an agreement with a vendor that has entered into an agreement with the General Services Agreement or another governmental agency located within or outside this State". CCHHS has been approved to be part of the 340B/Prime Vendor Drug Discount Program, a U.S. federal government program. Curascript is one of the two distributors of this product, manufactured solely by Merck. Under the 340B program, the Nexaplanon price is set and the same for the two distributors. CCHHS is approved to purchase from Curascript.
