**Recommended HRC motion: “I move to approve the 2016 Historic Resources Commission Annual Report to the Board of Supervisors as presented by staff.”**

**Background:**

The Historic Resource Commission (HRC) bylaws require the HRC to submit an annual report to the Board of Supervisors, including information about cases reviewed by the HRC, administrative reviews, and information regarding other historic preservation activities. The purpose of this item is to present the report to the HRC for approval.

**HRC Annual Report:**

The Carson City HRC (formerly known as the Historic Architecture Review Committee) was established in May 1981. The HRC evolved from a cultural resources inventory that was undertaken to document the remaining historic structures within Carson City. This resource inventory, completed in March 1980, also recommended the formation of two historic preservation districts within Carson City.

In May 1982, the Board of Supervisors created Carson City’s Historic District on the City’s west side with support from the Nevada Landmarks Society, the Nevada Division of Historic Preservation and Archeology, the Westside Protective Association and the Carson City Chamber of Commerce.

The seven member HRC includes building, design, and preservation professionals familiar with and sympathetic to the problems of older buildings and sites. Property owners within the Historic District are also represented on the HRC.

In 2016, the HRC held seven meetings and reviewed 48 applications, 26 of which were administratively approved by the HRC Chairman. This is just shy of double the number of applications in 2015, when the HRC held seven meetings and reviewed 26 applications, 11 of which were administratively approved by the HRC Chairman. The administrative approvals included re-roofing projects, fencing projects and minor maintenance projects in the Historic District. One decision of the HRC, the denial of a vinyl fence, was appealed to the Board, and the decision of the HRC was upheld. A copy of the applications list for 2016 is attached.

### Historic Preservation Awards

Each year Carson City recognizes significant historic preservation accomplishments to celebrate our community's history and heritage. All over the state, activities are held that remind us of the important historic resources that give meaning and a sense of place to our communities, and focus attention on how critical it is to make sure they are preserved. The annual preservation awards program honors individuals, organizations, or projects that have made important contributions toward preserving Carson City's heritage. This award recognizes excellence in advancing the goals of historic preservation while providing outstanding rehabilitation. The recipients are selected by the HRC.

On April 14, 2016, the HRC selected the following recipients to receive the 2016 Historic Preservation Award:

- The Nevada State Railroad Museum for the restoration of the historic Glenbrook Locomotive.
- Chris de Witt, Supervisor, Railroad Restoration, Nevada State Railroad Museum
- Rick Stiver, Restoration Specialist, Nevada State Railroad Museum
- Mort Dolan, Restoration Specialist, Nevada State Railroad Museum
- Lee Hobold, Restoration Specialist, Nevada State Railroad Museum

### Historic Resource Scavenger Hunt

The HRC and Planning Division organized the seventh annual Historic Resources Scavenger Hunt in May 2016 to help raise awareness of the Historic District, and to encourage both adults and children to become involved in the City's history and preservation efforts. HRC member LouAnn Speulda-Drews provided photos of architectural features of small portions of buildings within the District, and participants were required to identify the address of the location at which the photo was taken. The winner was selected from the participants with all correct answers. Adele's Restaurant graciously sponsored awards for the event.

### Historic Preservation Fund (HPF) Grant Program

The HRC submitted an application for the 2016 HPF Grant Program in the amount of \$75,000 to send HRC staff and the HRC chairman to the National Alliance of Preservation Commissions (NAPC) FORUM Conference in July 2016, HRC commissioner training through the NAPC's Commission Assistance Mentoring Program (CAMP) and additional Historic Structures Reports for the Nevada State Prison. The State Historic Preservation Office (SHPO) awarded Carson City \$27,000 of the originally requested \$75,000 for 2016 FORUM Conference attendance and the CAMP training program. The CAMP program has been scheduled for April 28-29, 2017.

For the 2017 cycle of the HPF Grant Program, the HRC has chosen to request \$38,000 to upgrade the Blue Line mobile app to allow for geo-located video, to provide for the purchase and installation of two beacons in the vicinity of the Blue Line to accommodate the functionality of the upgraded mobile app, and to advertise a launch event of the upgraded mobile app. The HPF Grant application was submitted in December 2016.

Carson City has been one of the more successful jurisdictions in Nevada in obtaining HPF grant funds over the years. The HRC and Planning Division have consistently requested relatively small amounts with each application in order to keep projects manageable, as a 40% match is required from the City. The City has typically been able to use "in kind" services to match the grant awards, including a significant amount of volunteer support from the HRC commissioners in addition to City staff time.
