ANNUAL TECHNOLOGY FUND REPORT CARSON CITY CLERK-RECORDER'S OFFICE

Expenditures in fiscal year 2016/2017 (through June 15, 2017):

Converting and Archiving records	\$9,806.89
Training and Travel	\$532.95
Technology	\$3,390.26
Total Expenditures:	\$13,730.10

Balance of technology fund as of June 15, 2017 is: \$38,676.90

NRS 247.306(3a)

The estimate of the proceeds that the county recorder will collect pursuant to NRS 247.305 are as follows:

- July 1, 2017-October 1, 2017: an estimate of 2,499 recordings @ \$3 collected = \$7,497
- *October 1, 2017-June 30, 2018: an estimate of 7,497 recordings @ \$5 collected = \$37,485

NRS 247.306(3b)

Proposal for expenditures of the proceeds FY 2017/18:

- Training and Traveling \$3,000.
- Conversion, digitizing and archiving records, \$20,000.

The funds are held in a separate account and the balance in the account must be carried forward to the next fiscal year, pursuant to NRS 247.306.

*Assembly Bill 169 of the 79th Legislative Session increased the technology fund from \$3 per recording to \$5 per recording effective October 1st 2017.
