Carson City Public Guardian's Office

Each County in Nevada is mandated to have a public guardian per NRS 253.150

Carson City adopted a resolution in 2011 limiting the Carson City public guardian cases to individuals 60 years or older unless there are extraordinary circumstances.

Who needs a public guardian and who is eligible to have a public guardian?

Per NRS 253.200, the proposed protected person must be a Nevada resident, must be an adult, must have no relative or friend suitable and willing to serve as his or her guardian, or must have a guardian who the court determines must be removed pursuant to NRS 159.185. The proposed ward must be deemed incompetent to handle their personal, medical and/or financial affairs by a licensed psychiatrist or physician.

Who is eligible to be a guardian?

Per NRS 159.044, a family member or a friend of the proposed protected person can be named guardian as long as they have not been convicted of a felony, are at least 18 years of age, have all of the identification required by the court, and can show cause why the proposed protected person needs a guardian.

Where do we get referrals for proposed wards?

We work closely with the Aging and Disability Services Division of the State of Nevada (EPS-Elder Protective Services), social service departments of area hospitals and care facilities. 99% of our referrals come from these sources.

How much is the cost to each protected person under guardianship?

The Board of Supervisors or County Commissioners of each county sets the fee charged to the protected person's assets. Carson City's fee is currently \$180.00 an hour and to be equitable the charge is two (2) hours per month per protected person. 88% of our clients are indigent and cannot pay for our services. Each county has a different fee structure and some counties do not charge fees.

What does the public guardian do for the protected person?

In a word, everything. Our office acts on the behalf of the protected person. We pay all of their bills (with their funds); see to their personal needs (shopping for clothing, personal care supplies, and other needs); make medical decisions and transport to doctors' appointments, if needed; use every resource offered by the federal, state and county governments (VA, SSA, Medicaid, etc.) to provide for and pay for their care; place the protected person in an appropriate care facility for the level of care needed; clean out their houses or apartments when they are placed in a facility; and sell residences, vehicles and personal possessions to pay for care. Each protected person has their own guardianship bank account and only their monies go into and out of that account. In other words, we act as the protected person.

My staff is dedicated to keeping this vulnerable population safe from abuse, neglect and exploitation at the hands of those who would do them harm. We personally see that exploiters are prosecuted for these crimes.

Our staff is exposed to bodily fluids, contagious diseases, bug infestations, combative and aggressive family members and protected persons, threats of bodily harm from exploitive parties, and other hazards. Staff members use protective gear when cleaning out protected persons' residences and when visiting protected persons in facilities under quarantine orders.

Additional information:

Our office currently has three full time positions (the public guardian, a case manager and an accounting clerk) and a social work intern position. The national average caseload for a public guardian is 30 cases per full time case manager; our office currently has 81 cases or 40 per full time case manager. We receive referrals weekly.

In addition to public guardians, there are fiduciary services offered through professional guardians, banks and investment companies, and guardianships by family and/or friends.

Public guardians are appointed by the district court of the county of residence of the protected person prior to placement. **For Example:** A proposed protected person lives in Minden but is placed in a facility in Carson City; the jurisdiction for the client is Douglas County.

The public guardian and staff belong to several multidivisional task forces helping to keep vulnerable people out of the hospitals and jail/court systems. These task forces are comprised of staff from the Nevada Department of Aging, the District Attorney's Office, the sheriff's office, the fire department, the hospital, the Carson City jail and other stake holders. With all of us working together we hope to save the community the expense of needless services and to get these people the help they need in the right setting.
