Time Requested: 15 minutes To: Mayor and Supervisors From: Public Works Department Subject Title: Action to introduce on first reading, Bill #_____, an ordinance amending Title 12 (Water, Sewerage and Drainage), Chapter 12.01 (Water Connection Charges and Use Rates), Section 12.01.020 (Schedule of Rates) by increasing all rates 14% effective on bills dated on or after February 1, 2007 and 14% effective on bills dated on or after July 1, 2007, and amending Section 12.01.030 (Schedule of Water Connection Charges, Lateral and Meter Box Sets, and Meter Set Fees) by increasing all charges and fees, except water connection charges remain the same, 14% effective on bills dated on or after February 1, 2007 and 14% effective on bills dated on or after July 1, 2007, and other matters properly related thereto. Staff Summary: The 2005 rate changes were based on \$30 million in capital improvements for the next 5 years and anticipated a 3 to 4% annual increase to cover the costs for Operations and Maintenance (O & M), increased supply, improved quality measures, and capital improvements. The 2007 capital program for the next five years is in the range of \$41 million (this includes \$27 million in direct capital costs and \$14 million of indirect ongoing operational costs) and will require a 28% annual increase in rates implemented in two stages of 14%. That is reflective of an 11% increase in O & M, which includes power costs, chemicals, water sampling, wholesale water purchases and leases; 3% increase for supply improvements; 6% increase for water system improvements; 4% increase to improve water quality; and 4% increase for other capital improvements. Explanation for Recommended Board Action: To improve Carson City's water system summer reliability, the City must increase the ability to meet current and future peak summer demands. The City has been experiencing water demand in excess of growth demand for several years. In addition, the City must be prepared to comply with new regulations that impact the water system, such as arsenic reduction, enhanced treatment requirements, disinfection by-products rule, and radon. The

following major capital projects are under construction or planned in addition to a number of smaller projects.

1. To increase the water system's ability to meet <u>current</u> peak summer demands, the City is in the process of securing sites to increase production capacity by approximately 1,500 g.p.m. in years 2007 - 2011.

Costs are estimated at approximately \$5,515,000.

2. The City has to replace two existing storage reservoirs (one 3 million tank and one 400,000 gallon tank) and build a new 1.5 million gallon tank to correct some hydraulic and pressure problems within the existing system over the next five years..

Costs are estimated at approximately \$4,400,000.

3. Increasing transmission line sizes over the next five years for improved water flows (hydraulics) throughout Carson City's distribution system is planned for at several locations in the City including Curry St., Fairview Drive, Hwy 50, and Saliman Drive.

Costs are estimated at \$1,500,000.

- 4. There is a need to develop a more reliable pumping system and to increase a firmer summer water supply from the Marlette Water System. In addition to upgrading/replacing the Marlette Lake pump system, an additional water line from State Tanks above Lakeview to Ash Canyon or a treatment facility between Lakeview and Timberline Subdivisions to realize increased water yields during peak irrigation season is required. Costs are estimated at \$4,500,000 to \$10,000,000, which is financed by the State of Nevada, and is being charged to the City through the cost of water delivered. This has added an additional; \$700,000/year to the operations and maintenance operation.
- 5. Several projects will be required to comply with current and upcoming regulations which will impact the water system. The revised arsenic standard of 10 parts per billion is the regulation of concern that must be dealt with during the next two to three years.

This will require installation of two new production wells and abandoning two arsenic impacted production wells. In addition, installation of treatment facilities to reduce the arsenic concentration is required for the two highest production impacted wells.

Costs are estimated at \$3,150,000.

6. The City must provide for relocation of water lines as part of phase 2 of the Carson City Freeway project.

Costs are estimated at \$5,500,000.

The 2005 rate changes were based on \$30 million in capital improvements for the next 5 years and anticipated a 3 to 4% annual increase to cover the costs for Operations and Maintenance (O & M), increased supply, improved quality measures, and capital improvements.

The 2007 capital program for the next five years is in the range of \$41 million (this includes \$27 million in direct capital costs and \$14 million of indirect ongoing operational costs) and will require a 28% annual increase in rates implemented in two stages of 14%. That is reflective of an 11% increase in O & M, which includes power costs, chemicals, water sampling, wholesale water purchases and leases; 3% increase for supply improvements; 6% increase for water system

improvements; 4% increase to improve water quality; and 4% increase for other capital improvements.

The proposed ordinance provides for the necessary revenue requirement to operate, maintain, meet new water quality standards, replace and expand the water system.

For the purpose of determining water connection charges, the water equivalent residential customer value, or portion thereof, is based upon a fee of [four thousand two hundred forty-six dollars (\$4,246.00) effective April 7, 2005;] four thousand five hundred forty-three dollars (\$4,543.00) effective October 7, 2005 per one WERC for every connection. For all other water connections not specified above, the connection charge is based on the "total WERCs" of the proposed development. The utilities director or his/her designee will assign a total WERC value to each development based on water usage

information provided to the city through completion and submittal of water usage information data or from previously supplied data generated through the review of similar or like uses and/or developments.

2. All fees for connection to the city water system will be collected at the time application is made for water service, unless otherwise required by this chapter.

CITY INSTALLED SERVICE

Applicability:

All connections to the city water system by the city will include all piping, connectors, trenching, backfill and resurfacing necessary to install a service lateral and make its connection to an adjacent and acceptable main waterline. The city will also furnish, install and connect a water meter box or pit setter to the service lateral, and furnish and install a radio frequency water meter of the size ordered by the customer, in accordance with the following fee schedule:

CITY INSTALLED DUAL PIT SETTER

Applicability:

The city will install water service to supply two separate customers through a dual pit setter connected to an adjacent and acceptable main waterline by a one-inch (1") service lateral. This service will include all connectors, trenching, backfill and resurfacing necessary to accomplish the installation to supply the two (2) adjoining customers, parcels or developments. The fee for this installation is [nine hundred seventy-four dollars (\$974.00) effective April 7, 2005; one thousand forty-two dollars (\$1,042.00) effective October 7, 2005] one thousand one hundred eighty-eight dollars (\$1,188.00) effective February 1, 2007; one thousand three hundred fifty-four dollars (\$1,354.00) effective July 1, 2007. Each five-eighths-inch (5/8") by three-fourths-inch (3/4") water meter furnished and installed in the dual pit will cost an additional [two hundred forty-six dollars (\$246.00) effective April 7, 2005; two hundred sixty-three dollars (\$263.00) effective October 7, 2005] three hundred dollars (\$300.00) effective February 1, 2007; three hundred forty-two dollars (\$342.00) effective July 1, 2007.

CUSTOMER INSTALL SERVICE

Applicability:

All connections to the city water system by persons other than city will be performed by persons properly licensed by the state of Nevada and Carson City to accomplish the type of work contemplated, and all work performed and all materials placed will be in accordance with the Carson City Code of Standard Specifications for Public Works Constructions. Prior to placement of a customer installed service, the applicable meter and meter set fee under the following schedule must be remitted. Under this fee schedule, no other work will be performed and no materials other than the prescribed water meter if requested by the
