Background/Issues & Analysis

Taxes have been delinquent on the attached list of properties since June 2014. The owners had a 2 year period in which to redeem the property by payment of all delinquent taxes, costs, penalties and interest legally chargeable against the property. The period of redemption expired June 5, 2017. Carson City recorded a deed on the properties as required by NRS 361.590 on that day. Eight parcels of Real Property remain delinquent. The total amount currently due is \$50,409.33.
