### Background:

The Historic Resource Commission (HRC) bylaws require the HRC to submit an annual report to the Board of Supervisors, including information about cases reviewed by the HRC, administrative reviews, and information regarding other historic preservation activities. The purpose of this item is to present the report to the HRC for approval.

### **HRC Annual Report:**

The Carson City HRC (formerly known as the Historic Architecture Review Committee) was established in May 1981. The HRC evolved from a cultural resources inventory that was undertaken to document the remaining historic structures within Carson City. This resource inventory, completed in March 1980, also recommended the formation of two historic preservation districts within Carson City.

In May 1982, the Board of Supervisors created Carson City's Historic District on the City's west side with support from the Nevada Landmarks Society, the Nevada Division of Historic Preservation and Archeology, the Westside Protective Association and the Carson City Chamber of Commerce.

The seven member HRC includes building, design, and preservation professionals familiar with the challenges of maintaining older buildings and sites, as well as the federal guidelines which provide guidance for preservation. Property owners within the Historic District are also represented on the HRC.

In 2017, the HRC held five meetings and reviewed 41 applications, 25 of which were administratively approved by the HRC Chairman. This is slightly down from the 48 applications reviewed in 2016. The administrative approvals included re-roofing projects, fencing projects and minor maintenance projects in the Historic District. The HRC also prepared a text amendment to clarify the fencing regulations in the district. A copy of the applications list for 2017 is attached.

### Historic Preservation Awards

Each year Carson City recognizes significant historic preservation accomplishments to celebrate our community's history and heritage. All over the state, activities are held that remind us of the important historic resources that give meaning and a sense of place to our communities, and focus attention on how critical it is to make sure they are preserved. The annual preservation awards program honors individuals, organizations, or projects that have made important contributions toward preserving Carson City's heritage. This award recognizes excellence in advancing the goals of historic preservation while providing outstanding rehabilitation. The recipients are selected by the HRC.

On March 9, 2017, the HRC selected the following recipients to receive the 2017 Historic Preservation Award:

- Jim Warren for work on his property at 603 Robinson Street.
- Jim and Margaret de Arrieta for work on their property at 216 Mountain Street.
- Ken Dorr of KL Dorr Consulting for his contributions to the reconstruction of the V&T Railway from Gold Hill to Carson City.

### Historic Resource Scavenger Hunt

The HRC and Planning Division organized the eighth annual Historic Resources Scavenger Hunt in May 2017 to help raise awareness of the Historic District, and to encourage the community become involved in the City's history and preservation efforts. HRC members LouAnn Speulda-Drews and Greg Hayes provided photos of architectural features of small portions of buildings within the District, and participants were required to identify the address of the location at which the photo was taken. The winner was selected from the participants with all correct answers. Adele's Restaurant graciously sponsored awards for the event. Twenty four participants submitted completed responses. In 2017, for the first time, the scavenger hunt was available on-line as well as in hard copy.

### Historic Preservation Fund (HPF) Grant Program

The HRC submitted an application for the 2017 HPF Grant Program in the amount of \$38,000 to upgrade the Blue Line mobile app to allow for geo-located video, to provide for the purchase and installation of two beacons in the vicinity of the Blue Line to accommodate the functionality of the upgraded mobile app, and to advertise a launch event of the upgraded mobile app. The application was not funded.

Utilizing 2016 HPF money, Carson City was able to host HRC commissioner training through the NAPC's Commission Assistance Mentoring Program (CAMP) April 28 – 29, 2017. Residents of the district, as well as Commissioners from Storey County and Reno participated in the training as well.

Carson City has been one of the more successful jurisdictions in Nevada in obtaining HPF grant funds over the years. The HRC and Planning Division have consistently requested relatively small amounts with each application in order to keep projects manageable, as a 40% match is required from the City. The City has typically been able to use "in kind" services to match the grant awards, including a significant amount of volunteer support from the HRC commissioners

in addition to City staff time. Please see the attached table for a complete list of the Historic Preservation Fund awards from 1987-2017.
