Hearings Officer Annual Report:

Starting in June of 2017, 8 liquor hearing meetings were held by the Hearings Officer of which 14 liquor licenses were approved. Those businesses were

Alcohol Compliance Checks:

Alcohol Compliance checks were conducted in March and in October. Two first citations were issued for both months with a total of four Administrative Citations issued. Those businesses were
