## **Background/Issues & Analysis**

NRS 361.5648(3) requires the tax receiver to issue a personal affidavit to the board of county commissioners affirming that a notice of delinquency has been mailed to property owners of each parcel having first year delinquent taxes (2017-2018). The affidavit must be issued within 30 days after mailing the original notice. There are 892 delinquent parcels to which due notice has been mailed in accordance with Nevada Revised Statute Chapter 361.5648. 11 letters have been returned, and 9 letters were undeliverable.
