### **Background/Issues & Analysis**

The next phase of cellular technology is 5G, which will require single ("small cell") antennas instead of macro towers to move mobile data traffic. Wireless service providers are proposing to install small cell equipment on City-owned poles and City-owned street lights located in City right-of-way to provide faster data coverage and capacity for mobile phone and device users. To facilitate the installation of this technology and maintain acceptable aesthetics of the City's streetscape, City staff has initiated discussion regarding the creation of City standards, permit processes, and a Master Agreement for setting the terms and conditions for the service providers. This report is being presented to the Board to provide preliminary information about the small cell proposals and to open discussion and potential direction to City staff.



## What others are doing

- City of Reno currently drafting code, license agreement, and mock ups
- Douglas County license agreement taken to BOC but not approved
- Clark County has been working with small cell providers since 2006
  - Currently seeing a large increase in requests
  - Working to refine their requirements

## Policy Direction



- Must meet requirements of Title 20
  - Special Use Permit or Administrative Review
  - Setbacks, Height
- Aesthetics will be a key component.
  - Preference is co-location. The placement of new poles is not desirous.
  - Non-antenna equipment and associated wiring must be concealed.
  - New above ground electrical is not allowed per CCDS 1.2.8
- Encroachment Permit
- License Agreement
- Fees
