# 8. FOR POSSIBLE ACTION: DISCUSSION AND POSSIBLE ACTION TO SCORE AND RECOMMEND TO THE BOARD OF SUPERVISORS THOSE APPLICANTS IN REQUEST OF ARTS AND CULTURE FUNDING FOR RACC SPECIAL EVENTS GRANTS FY18/19.

(5:52:14) – Chairperson McBride introduced the item. Mr. Salinas outlined the process by which the applications would be scored based on the previously-discussed criteria, and noted that the available funding was \$32,200, \$10,300 less than the total requested amount. He also suggested that the Commissioners reconvene at a later date to determine the exact award amounts and clarified that the Proscenium Players' application was submitted on time, even though it was stamped as received at a later date, due to the Community Development Building closure at 4 p.m. Ms. Yowell clarified that Commissioner Bugli, as an applicant, must recuse herself from voting on her organizations' requests. She also noted that Commissioner Abowd did not need to recuse herself because the Concert Under the Stars would be held at the Brewery Arts Center since they were renting the venue. Mr. Salinas invited the 11 applicants to present their requests, which are incorporated into the record, and noted that each Commissioner will fill out an individual score sheet which will be combined and averaged; however, any absence or recusal would not change the resulted averages or percentages. He also reminded applicants that they were only allowed three minutes per presentation. Ms. Yowell urged the commissioners to disclose any relationships, such as memberships, as organizations make their presentations.

(6:05:50) – Eleven requests were presented by nine organizations, all of which are incorporated in the agenda materials. The Brewery Arts Center, Capital City Arts Initiative, Carson City Classic Cinema Club, Carson City Symphony Association, Mile High Jazz Band Association, Pinkerton Ballet Theater, Proscenium Players, Sierra Nevada Ballet, and Wild Horse Productions presented their requests and responded to clarifying questions by the commissioners.

(7:07:45) – Mr. Salinas suggested a short recess in order to "put your numbers together". Chairperson McBride recessed the meeting.

He noted that since the requested total was higher than the available funds, he would offer to return with a few scenarios such as a distribution based on the ranked percentages or an across-the-board percentage cut of all requests.

The Cultural Commission is required to contain people on its Commission who have an appreciation for Carson City's rich cultural tradition, a broad and informed perspective of the arts along with a demonstrated knowledge and responsiveness to the existing arts community and community at large, in addition to representing a cross-section of the city's age, multicultural, socio-economic, professional, artistic and volunteer diversity.

Of consideration is CCMC 2.41.080 states:

"The commission will work with its partners in the community including, but not limited to, the Carson City Arts & Culture Coalition, Western Nevada College, Nevada Department on Cultural Affairs, Carson City's Convention & Visitors Bureau, the Carson City Redevelopment Authority and Carson City's future downtown business improvement district."

A discussion will take place in this regard as to potential candidates and possible recommendations will be made to the Carson City Board of Supervisors.
