Staff Summary: The Great Basin Beekeepers of Nevada propose adopting a resolution to designate Carson City as a Bee City USA affiliate. This program serves to promote a healthy and sustainable habitat in order to support vital pollinator populations for the benefit of our health and economy. Adopting the Bee City USA designation will encourage citizens and department staff to make pollinator friendly choices for the benefit of our community.

#### **Background/Issues & Analysis**

Established in 2015, the Great Basin Beekeepers of Nevada is a grassroots group based out of the Carson City area that focuses on promoting healthy, sustainable habitat for bees and other pollinators by actively pursuing education of the public. In 2017, the Great Basin Beekeepers of Nevada contacted Mr. Mayor Crowell to pursue designating Carson City as the first Bee City USA affiliate in Nevada. The Bee City USA program endorses a set of commitments for creating sustainable habitats for pollinators, which are vital to feeding the planet. This program supports the creation of a healthy pollinator habitat by encouraging citizens to pursue cultural practices, such as planting native plants that will provide forage for a variety of pollinator species. Additional commitments include implementing best management practices for pollinators in the Parks, Recreation & Open Space Department. Examples include: incorporating pollinator friendly plant species into restoration seed mixes, encouraging staff to use integrated pest management (IPM) strategies whenever possible (i.e. physical removal), as well as encouraging pollinator friendly plant choices when reviewing development proposals. No fiscal impacts are anticipated from adopting these practices, and other non-fiscal resources can be provided to the public such as education on best practices. Additionally, in coordination with the Great Basin Beekeepers of Nevada, pollinator curriculum can be incorporated into the youth recreation programs. Adopting these practices in our community will ensure that pollinator populations are able to thrive in Carson City, ensuring healthy and abundant agricultural production and native landscapes.

# CARSON CITY BOARD OF SUPERVISORS RESOLUTION NO. \_\_\_\_

## A RESOLUTION OF THE CARSON CITY BOARD OF SUPERVISORS DESIGNATING CARSON CITY, NEVADA AS A BEE CITY USA® AFFILIATE.

WHEREAS, the mission of BEE CITY USA is to galvanize communities to sustain pollinators, responsible for the reproduction of 90% of the world's wild plant species, by providing them with healthy habitat, rich in a variety of native plants; and

WHEREAS, due in part to the tremendous diversity of wild native bees, and introduced honey bees, we have very diverse dietary choices rich in fruits, nuts and vegetables; and

WHEREAS, bees and other pollinators have experienced population declines due to a combination of habitat loss, use of pesticides, and the spread of pests and diseases; and

WHEREAS, in order to enhance understanding among local government staff and the public about the vital role that pollinators play and what each of us can do to sustain them, Carson City chooses to support and encourage pollinator habitat creation and enhancement on both public and private land; and

#### WHEREAS, ideal pollinator-friendly habitat:

- Provides diverse and abundant nectar and pollen from plants blooming in succession throughout the growing season;
- Provides water for drinking, nest-building, cooling, diluting stored honey, and butterfly puddling;
- Provides undisturbed spaces (leaf and brush piles, un-mowed fields or field margins, fallen trees and other dead wood) for nesting and overwintering for wild pollinators;
- Has pesticide use carried out with least ill effects on pollinators;
- Is comprised of mostly, if not all, native species of annual and perennial forbs, grasses, vines, shrubs, and trees in landscapes, parks and open space;
- Includes, where possible, designated pollinator zones in public spaces with signage to educate the public and build awareness; and
- Provides for safe and humane removal of honey bees when required.

WHEREAS, pollinator-friendly communities can benefit local and regional economies through healthier ecosystems, increased vegetable and fruit crop yields, and increased demand for pollinator-friendly plant materials from local nurseries and growers; and

WHEREAS, supporting pollinators fosters environmental awareness and sustainability, and increases interactions among community stewards; and

### WHEREAS, designating Carson City as a BEE CITY USA community would:

- Enhance understanding among the public about the vital role that pollinators play and how to sustain them;
- Encourage pollinator habitat creation and enhancement on both public and private land;
- Honor and emphasize Carson City's rich history, both past and present;
- Benefit local businesses that support pollinators;
- Celebrate our cultural identity as a community that values sustainable practices;
- Contribute to tourism in the region;
- Improve food security and health by supporting local food sources; and
- Encourage local collaboration on projects that promote environmental education and sustainable practices.

### NOW, THEREFORE, Carson City resolves as follows:

- 1. Carson City, through its Parks, Recreation & Open Space Department is hereby designated as the BEE CITY USA sponsor and will facilitate the program on behalf of the City.
- 2. The Senior Natural Resource Specialist of Carson City is designated as the BEE CITY USA liaison.
- 3. Facilitation of the Carson City BEE CITY USA program is assigned to the Great Basin Beekeepers of Nevada.

- 4. The Parks, Recreation and Open Space Department is authorized to, and should encourage and support:
  - Celebration: Annually participate in National Pollinator Week (third full week of June) by encouraging educational events, pollinator habitat plantings or restoration, proclamations or promotions that showcase Carson City's commitment to enhancing pollinator health and habitat within the City's park system.
  - Publicity & Information: Install and maintain at least one authorized BEE CITY USA street sign in a prominent location, and create and maintain information on the Carson City website which includes: a copy of this resolution, links to the national BEE CITY USA website, contact information for the BEE CITY USA liaison (Senior Natural Resource Specialist), and highlights the pollinator-friendly activities the community has accomplished the previous year(s).
  - **Habitat**: Develop and implement a program to create or expand pollinator-friendly habitat, which can include, but is not limited to:
    - i. Identification and inventory of Carson City property that can be enhanced with pollinatorfriendly plantings;
    - ii. Creation of a recommended locally native species list to include forbs, grasses, vines, shrubs, and trees and a list of local suppliers for those species;
    - iii. Encourage least toxic integrated pesticide practices throughout the City;

iv. Dissemination of informational and educational materials to the public; and

- v. Tracking annual area of pollinator habitat created or enhanced by square footage and/or acreage.
- d. Policy: Review the Carson City Master Plan and the City's Development Codes to encourage pollinator friendly habitat, pesticide management and consider acknowledgement of the BEE CITY USA designation during future plan and policy updates.
- Renewal: After completing the first full year as a BEE CITY USA affiliate, each January, apply for renewal of the Carson City's BEE CITY USA designation by including a report of the previous year's BEE CITY USA activities, and collaborate with the Great Basin Bee Keepers of Nevada to fund the renewal fee based on Carson City's population.
