Staff Summary: Nevada Revised Statutes (NRS)361.595 (2) provides that if a "property is to be sold, the board of county commissioners may make an order, to be entered on the record of its proceedings, directing the county treasurer to sell the property particularly described therein, after giving notice of sale, for a total amount not less than the amount of the taxes, costs, penalties and interest legally chargeable against the property as stated in the order."

Previous Action

Background/Issues & Analysis

Taxes have been delinquent on each of the properties included on the list of properties submitted as supporting material for this agenda item. Pursuant to NRS 361.570, the owners of those properties had a two- year redemption period in which to pay all delinquent taxes, costs, penalties and interest legally chargeable against the property. The period of redemption has expired and Carson City recorded a deed on the properties as required by NRS 361.590 on June 4, 2018. The taxes on eight properties remain delinquent. The total amount currently due is \$53,325.52. While this required step towards a tax sale is now being taken, some of these properties may be protected from sale under US Bankruptcy laws.
