A joint meeting of the Carson City Regional Transportation Commission and the Carson City Regional Planning Commission was held July 25, 1990, at the Carson City Community Center, Sierra Room, 851 East William Street, Carson City, Nevada, beginning at 6:30 p.m.

CALL TO ORDER: Chairman Steele called the Regional Planning Commission to order at 7:00 p.m. Chairman Feticc called the Regional Transportation Commission to order at 7:02 p.m.

1. ROLL CALL AND DETERMINATION OF QUORUMS OF REGIONAL TRANSPORTATION COMMISSION AND REGIONAL PLANNING COMMISSION: Roll call was taken for the Regional Planning Commission and a quorum was present. Roll call was taken for the Regional Transportation Commission and a quorum was present.

2. DISCUSSION AND POSSIBLE ACTION REGARDING THE ADOPTION OF THE DRAFT STREET AND HIGHWAY ELEMENT FOR INCLUSION INTO THE CITY MASTER PLAN: (1-0125) Mr. Brotzman reviewed this matter and introduced Michael Connors of JHK and Associates. Mr. Connors presented the Proposed Draft Street and Highway Element and answered questions from the Commission members. Discussion ensued regarding the impact on legislative sessions, Capitol Complex traffic, the proposed traffic signal system, the impact of development on surrounding communities, the extension of Nye Lane and/or Graves Lane and possible state funding for development. Following discussion, the meeting recessed at 8:20 p.m. and reconvened at 8:35 p.m. Community Development Director Walter Sullivan distributed and reviewed his staff report regarding recommendations for the Transportation Plan Map. Chairman Steele then opened the floor to public comment and Dick Murray of the Main Street Committee encouraged the pursuit of federal funding for the bypass and inquired as to how the proposed street and highway element relates to the transit system developed for Carson City in 1979. Anthony Calabro, President of Western Nevada Community College presented comments in support of an extension of Graves or Nye Lanes. Following public comments, Kay Bennett moved to adjourn the meeting of the Regional Transportation Commission at 8:45 p.m. Robin Williams-Auer seconded the motion. A vote was taken and the motion carried 3-0. Following further discussion, Commissioner Pisiewski moved that the Planning Commission continue this item to their regular meeting which, if we have two separate sessions, would be the 29th of August, Wednesday, and that the consultant

be given all of his comments by the second Friday in August which would be August 10th as a deadline. Commissioner Mally seconded the motion. A vote was taken and the motion carried 5-0.

4. ADJOURNMENT: Commissioner Pisiewski moved to adjourn the meeting at 9:20 p.m. Commissioner Calhoun seconded the motion. A vote was taken and the motion carried 5-0.
