Agenda Title:	For Possible Action: To dedicate and accept the dedication of a right-of-way from APN 010-116-01, also known as a portion of Sierra Vista Lane. (Stephanie Hicks, SHicks@carson.org)		
	Staff Summary: APN 010-116-01 is a triangular shaped parcel located southeast of Carson River Road and bisected by Sierra Vista Lane. On August 16, 2018, the Carson City Board of Supervisors adopted a Resolution consenting to a relinquishment and land transfer agreement for this parcel from the State of Nevada, Department of Transportation to Carson City. Now that the parcel is owned by the City, the parcel should be dedicated as right-of-way as it is bisected by Sierra Vista Lane and is not developable.

### Proposed Motion

I move to dedicate and accept the dedication of a right-of-way from APN 010-116-01, also known as a portion of Sierra Vista Lane.

#### Board's Strategic Goal

#### Previous Action

April 24, 2009 - The Carson City Regional Transportation Commission entered into an agreement with NDOT to accept the right-of-way for a portion of SR-513 which included portions of East Fifth Street, Carson River Road and Pinion Hills Drive.

August 16, 2018 - The Carson City Board of Supervisors adopted a Resolution accepting a relinquishment and land transfer agreement from the State of Nevada, Department of Transportation to Carson City for an approximately 15,203 square foot parcel along Sierra Vista Lane, also known as APN 010-116-01.

## **Background/Issues & Analysis**

The Nevada Department of Transportation (NDOT) relinquished to Carson City the right-of-way for a portion of SR-513 which included portions of East Fifth Street, Carson River Road and Pinion Hills Drive in May of 2009. During the recent project to reconstruct Sierra Vista Lane, it was discovered that a surplus parcel of land along Sierra Vista Lane was still owned by NDOT. The triangular shaped parcel is southeast of Carson River Road and is bisected by Sierra Vista Lane. After further discussions with NDOT staff, it was determined that this surplus parcel should have been transferred with the relinquishment of SR-513 and is no longer needed by NDOT.

On August 16, 2018, the Board of Supervisors adopted a Resolution accepting the relinquishment and land transfer of the property. This item will dedicate the parcel as right-of-way as it is bisected by Sierra Vista Lane and would not be developable.


