# Background/Issues & Analysis

NRS 237.030 to 237.150, inclusive, require the City to prepare a Business Impact Statement as a statutory prerequisite to the adoption of any rule as defined in NRS 237.060, unless an exemption applies. This Business Impact Statement has been prepared in accordance with NRS 237.080.

On May 8, 2019, the Carson City Business License Division emailed a letter and a copy of the draft ordinance to the Executive Director of the Chamber of Commerce, and the General Managers of Casino Fandango, Gold Dust West Carson City, Carson City Nugget, Max Casino, and Bodines Casino. The letter informed them of the proposed changes to CCMC and informed them of a meeting that would take place on June 6, and elicited comments regarding the same.

The Executive Director of the Chamber of Commerce responded, essentially verifying the scope of changes, and advised of no concerns. Staff discussed the proposed modifications with a representative for Gold Dust West, but has not received any formal comments. The conversation was of a clarifying nature.

Based on the above, staff is asking the Board of Supervisors to make a finding that the changes to CCMC do not impose a direct or significant economic burden or directly restrict the formation, operation, or expansion of a business.
