Agenda Title: For Possible Action: Discussion and possible action regarding a memorandum of understanding between the Carson City Fire Department Classified Chief Officers Association (CCOA), the Carson City Fire Fighters Association, International Association of Fire Fighters Local 2251 (Local 2251), and Carson City regarding CCOA's withdrawal of representation of the Battalion Chief's supervisory bargaining unit and the representation of that bargaining unit by Local 2251. Staff Summary: In early 2019, the Battalion Chiefs voted to be represented by Local 2251 as a supervisory bargaining unit instead of maintaining their own union, CCOA, and Local 2251 agreed to represent the bargaining unit. This memorandum of understanding accomplishes the intended voluntary withdrawal of CCOA as bargaining agent and recognition of representation by Local 2251.

Previous Action

November 12, 2013 – the Board of Supervisors approved the amended collective bargaining agreement between the CCOA and Carson City effective from July 1, 2010 to June 30, 2020.

Background/Issues & Analysis

In early 2019, the Battalion Chiefs voted to be represented by Local 2251 as a supervisory bargaining unit instead of maintaining their own union, CCOA, and Local 2251 agreed to represent the bargaining unit. The relevant statutes and regulations only permit Carson City to bargain with a new bargaining agent upon permission from the Nevada Local Government Employee-Management Relations Board, or upon the voluntary withdrawal of the existing bargaining agent. This memorandum of understanding accomplishes the voluntary withdrawal of CCOA as bargaining agent and recognition of representation by Local 2251.

MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding ("MOU") is made by and among Carson City, Nevada, a Consolidated Municipality ("City"), the Carson City Fire Department Classified Chief Officers Association ("CCOA"), and the Carson City Fire Fighters Association, Local 2251 of the International Association of Firefighters ("Local 2251"). City, CCOA, and Local 2251 may be individually referred to as "Party" and collectively referred to as "Parties."

RECITALS:

WHEREAS, City and CCOA have entered into the Second Amended Collective Bargaining Agreement, expiring on June 30, 2020, governing supervisory personnel (Battalion Chiefs) in the Carson City Fire Department ("CCOA Agreement"), and City and Local 2251 have entered into the Third Amended Collective Bargaining Agreement, expiring on June 30, 2023, governing non-supervisory Carson City Fire Department personnel ("Local 2251 Agreement"); and

WHEREAS, the five members of CCOA have unanimously voted to have Local 2251 represent their interests in negotiations with the City, and the membership of Local 2251, by majority vote, approved Local 2251's representation of the Battalion Chiefs' supervisory bargaining unit; and

WHEREAS, the parties desire to continue the CCOA Agreement until its agreed upon expiration;

NOW, THEREFORE, in consideration of the mutual promises and conditions contained in this MOU, the Parties do agree as follows:

1. **Withdrawal of CCOA Representation.** Pursuant to NAC 288.145, CCOA withdraws its representation of the Carson City Fire Department supervisory bargaining unit, consisting of the five Battalion Chiefs.

2. **Recognition of Local 2251 Representation.** Pursuant to NRS 288.160, City recognizes Local 2251 as the bargaining agent for the Carson City Fire Department supervisory bargaining unit, consisting of the five Battalion Chiefs.

3. **Continuation of the CCOA Agreement.** Pursuant to Article 30 of the CCOA Agreement, City and Local 2251 agree that the CCOA Agreement shall continue in effect between City and Local 2251, with Local 2251 defined as the "Association" in that Agreement in place of CCOA, until its expiration date on June 30, 2020.

4. **Effective Date.** The Parties agree that this MOU is effective retroactively on January 18, 2019.

5. Entire Agreement. This MOU constitutes the entire agreement of the Parties and is the complete and exclusive statement of the promises, representations, negotiations, discussions, and other agreements that may have been made in connection with the subject matter hereof.

Counterparts. This MOU may be executed in counterparts, each of which shall 6. be deemed to be an original but all of which, taken together, shall constitute one and the same agreement.

The Battalion Chiefs will remain under their current Collective Bargaining Agreement separate from the Non-Supervisory Collective Bargaining Agreement until future negotiations and agreements from all parties involved create an updated Collective Bargaining Agreement. At that point Collective Bargaining Agreements may be combined if found to be in the best interest of all parties involved. Following this acceptance, the Battalion Chiefs will operate under the Constitution and Bylaws of Local 2251 with all rights and privileges pertaining thereto.
