**Agenda Title:** For Possible Action: Discussion and possible action regarding a proposed increase to the Curascript's purchase order (PO) from \$44,808 to a total amount not to exceed \$65,000 for Fiscal Year 2020. (Nicki Aaker, naaker@carson.org)

Staff Summary: Carson City Health and Human Services (CCHHS) purchases long acting birth control and pharmaceuticals through the Health Resources and Services Administration (HRSA) 340B Drug Pricing Program from Curascript. The purchases are funded by the Health and Human Services State Family Planning Grant, clinical services revenue and the Title X Grant. Due to the COVID-19 response, most of the staff working within the State Family Planning Grant were re-assigned to work on activities related to COVID-19, which the State Family Planning Grant would not cover. The grantor has agreed to allow the transfer of funds from Salaries/Benefits to Operating, which will allow CCHHS to purchase Nexplanons, a long acting birth control, from Curascript for clinical services family planning patients.
