Staff Summary: The CDBG-CV provides funds for a range of eligible activities that prevent and respond to the spread of the coronavirus (COVID-19). The CDBG-CV funding granted to Carson City for FY 2021 is \$283,213—no additional funding is expected. Four public service project applications were submitted, for a total request of \$208,682. Staff is requesting that \$28,322 be allocated for administration of the grant, and \$208,682 be allocated to the four applications that were received for public services projects for COVID-19: \$79,826 to the Boys and Girls Club of Western Nevada, \$20,080 to St. Vincent de Paul Society, \$57,191 to the Nevada Health Centers, and \$51,585 to Spirit of Hope. The remaining \$46,209 will not be allocated in this grant cycle but will be advertised alongside

the regular CDBG funding in fall of 2020.

Background/Issues & Analysis

The CDBG-CV provides funds for a range of eligible activities that prevent and respond to the spread of the coronavirus. The CDBG-CV funding granted to Carson City for FY 2021 is \$283,213—no additional funding is expected. A maximum of 10% is allowed for administration, which totals \$28,322; staff anticipates spending the total amount allowed for administration. No other caps have been placed on CDBG-CV expenditures.

Carson City placed advertisements for the funding opportunity and received 4 applications for public service programs, for a total request of \$208,682. The total amount of applications for funding is less than the amount available for CDBG-CV. Staff formed an Application Review Work Group (ARWG) to evaluate and rank the applications and to make funding recommendations based on both meeting the CDBG national objectives and the community priorities. The ARWG conducted a phone meeting on August 7, 2020 and recommends full allocation of funds to the applications that were received: \$79,826 to the Boys and Girls Club of Western Nevada to expand their daycare program to observe COVID-19 social distancing and sanitation measures, \$20,080 to the St. Vincent de Paul Society to supply cleaning and sanitation supplies to the Nights Off the Street

Warming Shelter, \$57,191 to the Nevada Health Centers to convert the Sierra Nevada Health Center parking area into a COVID-19 screening and testing area, and \$51,585 to Spirit of Hope for a transportation van for safe transportation to observe COVID-19 restrictions. Staff is requesting that \$208,682 be allocated to these public services projects for COVID-19 as recommended by the ARWG.

The remaining \$46,209 will not be allocated in this grant cycle but will be advertised alongside the regular CDBG funding in fall of 2020.

If approved, staff will then forward the final approved recommendations to the Nevada Governor's Office of Economic Development for their consideration and allocation of the CDBG-CV funds.

Subject: CDBG-COVID 19 Funding Proposals

The Board of Supervisors is required to make a final recommendation and approval of funding for the Community Development Block Grant- Coronavirus (CDBG-CV) projects to the Governor's Office of Economic Development. Carson City's CDBG-CV allocation for Fiscal Year 2021 is \$283,213. The recommended funding amount is \$28,322 (10%) for grant administration. \$208,682 will be allocated to Public Service Programs related to Coronavirus (COVID 19), and \$46,209 not allocated in this grant cycle will be advertised alongside the regular CDBG funding fall 2020.

As part of the abbreviated CDBG Citizen Participation requirement, an online workshop session was held on June 16, 2020 to review the CDBG-CV requirements. The request for applications was posted on Carson NOW, City Hall, Carson City Community Development office and the Carson City website. Applications were also solicited by e-mail to local community service organizations.

Applications were due on July 24, 2020. The Application Review Work Group (ARWG) held a conference phone call August 7, 2020, where the ARWG ranked and evaluated the proposed program applications for community need, projected outcome, and compliance with State and HUD requirements. The ARWG consisted of 5 volunteers representing both community members and subject matter experts. These members are:

1) Project Name: Expanded COVID 19 Relief

Agency: Boys and Girls Club of Western Nevada

Funding Request: \$79,825.42 **Recommendation:** \$79,826.00

Objective: Serving low- to moderate-income (LMI) persons.

Description: The Boys and Girls Club is requesting funding to expand their daycare

program to include childcare at a limited capacity, following strict mask wearing, social distancing and sanitization measures for both staff and clients. The request includes additional tables, chairs, internet bandwidth, radios,

transportation and cleaning supplies.

DEPARTMENT OF FINANCE

Funding Recommendation Rationale: Approved under Section 105(a)(8) of the Housing and Community Development Act of 1974 (HCDA), provisions of public services. The ARWG is recommending full funding based on the amount of money received from CDBG. The Boys and Girls Club Expansion is a first year CDBG program; in addition, the ARWG put emphasis on the fact that the program is critical for those local families that need to work during the COVID-19 hybrid school schedule.

2) Project Name: Nights Off The Street Warming Shelter (N.O.T.S.)

Agency: St. Vincent de Paul Society

Funding Request: \$20,080.00 **Recommendation:** \$20,080.00

Objective: Serving low- to moderate-income (LMI) persons.

Description: N.O.T.S. is a partnership between seven Carson City churches that have come

together to provide a secure and supervised sleeping environment for homeless individuals from November 1st to March 31st each year. Due to COVID-19, N.O.T.S. is requesting funds for cleaning and sanitation supplies,

PPE and bedding for each person, not to be reused.

Funding Recommendation Rationale: Approved under Section 105(a)(8) of the Housing and Community Development Act of 1974 (HCDA), provisions of public services. The ARWG is recommending full funding based on the amount of money received from CDBG. N.O.T.S. is a first year CDBG program. The ARWG unanimously voted to support this request due to the importance of having a clean and safe location for people to sleep during the winter months. In addition, several of the ARWG members have worked with and/or volunteered for this program and state that the program is well organized, professional and important to our community.

3) Project Name: Nevada Health Centers COVID 19

Agency: Nevada Health Centers

Funding Request: \$57,190.22 **Recommendation:** \$57,191.00

Objective: Serving low- to extremely low-income (LMI) persons.

Description: Nevada Health Centers is requesting funding to help prevent, prepare and

respond to the Coronavirus by converting their existing Sierra Nevada Health Center parking area into a limited contact, free-standing, weather-protected, covered area in which members of the public can be screened, tested and

eventually immunized for COVID-19.

Funding Recommendation Rationale: Approved under Section 105(a)(8) of the Housing and Community Development Act of 1974 (HCDA), provisions of public services. The ARWG is recommending full funding for this request. The ARWG felt that the need for this structure is essential to the health and wellbeing of Carson City residents, not only for COVID-19, but for testing and immunization for other illnesses. The ARWG stated that they fully support this project.

4) Project Name: Transportation Van COVID 19

Agency: Spirt of Hope Funding Request: \$51,584.33 **Recommendation:** \$51,585.00

Objective: Serving low- to extremely low-income (LMI) persons.

Description: Spirit of Hope provides clean and sober housing to low income individuals

who are recovering from addiction and/or homelessness. The request is for the purchase of one 12-passenger van in order to provide safe transportation to their clients. Due to COVID-19 restrictions, the van would allow Spirit of Hope staff to drive several people at a time to appointments and needed services. Due to social distancing guidelines, the van would be filled at half capacity allowing for safe travel. Currently Spirit of Hope does not own a van or any other transportation for their clients. Staff vehicles are being used for the transport of clients.

Funding Recommendation Rationale: Approved under Section 105(a)(8) of the Housing and Community Development Act of 1974 (HCDA), provisions of public services. The ARWG is recommending full funding for this request. Spirit of Hope works with the Carson City Public Guardian's Office and the need to help transport clients according to the ARWG is high. ARWG supports this request and states that having Spirit of Hope staff drive clients in their personal vehicles is costly and does not allow for the distancing recommended for COVID-19.

Potential Additional Funding Available:

No additional funding is expected from the Nevada Governor's Office of Economic Development.

Eligibility Requirement

In order to be eligible for funding, every CDBG-funded activity (excluding planning and administration) *must* qualify as meeting one of the three national objectives of the program:

- Benefiting low- and moderate-income (LMI) persons or a low-income area,
- Preventing or eliminating slums or blight, or
- Meeting an urgent community development need due to threat to community health and welfare (e.g. natural disaster emergencies).

Past CDBG public facility and public service projects in Carson City have met the LMI criteria. This means projects that get funded qualify by either:

- 1. Limited Clientele criteria: Serving persons where at least 51% of the clientele are LMI persons (senior citizens are also classified as LMI under this category); or
- 2. Area Benefit criteria: Meeting the needs within a service area where at least 51% of the residents in that area are LMI persons. (HUD provides data on the percentage of LMI persons within the Census Block Groups.)

It is very important that the program or project staff document the number of LMI persons served for grant monitoring and audit purposes.

Eligible activities for the use of CDBG-CV funds and examples of such activities include:
