I, Aubrey Rowlatt, Carson City Clerk-Recorder, do hereby certify the enclosed to be a full, true, and correct Summary Report and Precinct Report of Carson City, Nevada polled at the November 3, 2020 General Election.

Of the 29,781 ballots cast in the 25 precincts:

1. One (1) voter has been accounted for as a "Fleeing Voter" at the polling location during early voting.
2. One (1) voter has been accounted for as voting a mail ballot and an early voting in-person ballot.

The foregoing discrepancies would not alter the outcome of any race in this General Election.

One (1) voter cast a mail ballot and voted in person at the polling location. This discrepancy does not affect the above amounts.
