Agenda Title: For Possible Action: Discussion and possible action regarding a proposed \$100,000

increase in purchase authority for the purchase of Sodium Hypochlorite, for a new not to exceed total amount of \$300,000; a proposed extension of the purchase authority through June 30, 2021; and authorization to purchase Sodium Hypochlorite through joinder contract #212528, from the City of Tucson, through Omnia Partners, with Thatcher Company of Arizona, Inc.. Staff Summary: Each year the Carson City Public Works and Parks and Recreation Departments purchase Sodium Hypochlorite, otherwise known as bleach, for use in swimming pools, the water treatment plant, and the wastewater treatment plant. On June 18, 2020, the Board of Supervisors granted the Departments partial annual authority to purchase Sodium Hypochlorite in a not to exceed amount of \$200,000 through January 31, 2021. At that time, the joinder contract being used to purchase Sodium Hypochlorite expired on January 31, 2021. The City of Tucson has executed a new joinder contract with the same vendor. The Carson City Public Works Department requests a \$100,000 increase in purchase authority, for a total not to exceed amount of \$300,000, to purchase Sodium Hypochlorite through the new joinder contract through the end of fiscal year 2021. The \$100,000 increase is for Sodium Hypochlorite use at the wastewater treatment plant; no additional increase is needed for the City's swimming pools or for the water treatment plant.

On June 18, 2020, the Board of Supervisors approved the proposed request for authority to purchase Sodium Hypochlorite (Bleach) utilizing joinder contract #150063-SK-A from the City of Las Vegas, through National IPA (now a part of Omnia Partners), with the Thatcher Company of Arizona, Inc., for a total not to exceed amount of \$200,000 through January 31, 2021 (File No. 20300028).

Background/Issues & Analysis

The prior joinder contract that the City used to purchase Sodium Hypochlorite expires on January 31, 2021. The City of Tucson, now the lead agency, working with Omnia Partners, has entered into a new contract with Thatcher Company of Arizona, Inc. to provide water treatment chemicals. The new contract is effective October 1, 2020 through September 30, 2021, with the option to renew for four additional one-year periods through September 30, 2025.

The City of Tucson, AZ Department of Procurement issued RFP #212528 on July 1, 2020, to establish a national cooperative contract for Water Treatment Chemicals (Polymers & Misc.).

The solicitation included cooperative purchasing language in the National Contract section (RFP page 2):

(RFP, Page 2) National Contract

The City of Tucson, as the Principal Procurement Agency, defined in Attachment A, has partnered with OMNIA Partners to make the resultant contract (also known as the "Master Agreement" in materials distributed by OMNIA Partners) from this solicitation available to other public agencies nationally, including state and local governmental entities, public and private primary, secondary and higher education entities, non-profit entities, and agencies for the public benefit ("Public Agencies"), through OMNIA Partners' cooperative purchasing program. The City of Tucson is acting as the contracting agency for any other Public Agency that elects to utilize the resulting Master Agreement. Use of the Master Agreement by any Public Agency is preceded by their registration with OMNIA Partners (a "Participating Public Agency"). Attachment A contains additional information about OMNIA Partners and the cooperative purchasing agreement.

On August 3, 2020 proposals were received from the following offerors:

- Thatcher Company of Arizona, Inc.

The proposals were evaluated by an evaluation committee. Using the evaluation criteria established in the RFP, the committee elected to enter into negotiations with Thatcher Company of Arizona, Inc. and proceeding with contract award upon successful completion of negotiations.

The City of Tucson, OMNIA Partners and Thatcher Company of Arizona, Inc. successfully negotiated a contract, and the City of Tucson executed the agreement with a contract effective date of October 1, 2020.

Diversity Certification:

Thatcher Company, Inc. is a minority owned company with 2/3 of the owners women and further utilizes Tier II diversity suppliers whenever the opportunities allow.
