A. ACTION TO APPROVE A FULL BAR LIQUOR LICENSE FOR MR. JEFFERY E. DONOVAN, OWNER OF SCAVO'S BAR, LOCATED AT 4750 HIGHWAY 50, SUITE 1, IN CARSON CITY (8:42:15) (8:45:52) - Mr. Donovan was not present. The item was deferred to the next Board meeting. No formal action was taken on this license.

B. ACTION TO APPROVE A FULL BAR LIQUOR LICENSE FOR MR. CHEN HUAWEI AND MR. CHEN HUA YOU, MEMBERS AND LIQUOR MANAGERS OF MING GONG RESTAURANT, LLC, DOING BUSINESS AS MING'S RESTAURANT, LOCATED AT 2330 SOUTH CARSON STREET (8:42:45) - Chen Huawei, Chen Hua You, and their interpreter Steven Madar were present. The Sheriff's Office did not object to their having a license. Discussion among the Board noted that the establishment had recently failed a sting operation. The owners were cautioned regarding the seriousness with which the Board viewed such failures and the importance of strictly adhering to Liquor Laws. Mr. Madar indicated that he would be present at the establishment and that staff members can speak and read proficient English. The problem occurred prior to the current owners taking over the operation. Mr. Madar also indicated that he was not at the establishment at the time of the sting. Member Staub moved to approve a full bar liquor license for Mr. Chen Huawei and Mr. Chen Hau You, members and liquor managers of Ming Gong Restaurant, LLC, dba Ming's Restaurant, located at 2330 South Carson Street; fiscal impact is \$1,000 for original new fee, \$575 for an investigation fee, and \$200 for a quarterly fee. Member Aldean seconded the motion. Motion carried 6-0.

There being no other matters for consideration as the Liquor and Entertainment Board, Chairperson Teixeira adjourned the Liquor and Entertainment Board.
