AGENDA TITLE: For Possible Action: Discussion and possible action regarding a request to amend a Special Use Permit (LU-2020-0041) to allow for the installation of a backup generator for the Carson City School District Office, on property zoned Public (P), located at 1402 West King Street, APN 003-171-01. (Heather Ferris, hferris@carson.org)

Summary: On November 17, 2020 the Planning Commission approved a 975 square foot addition and remodel to the existing District Office. Since this approval, the applicant has determined the addition of a backup generator will be beneficial to provide power to the District Office for 24 hours in the event of a power outage. The generator is proposed to be located north of the District Office in the existing equipment yard. The generator will be screened by the existing slatted chain-link fence and will be installed within a sound attenuated weather protective enclosure. Per CCMC 18.04.170, the use may only be established or modified subject to a Special Use Permit. Since the generator was not contemplated as part of LU-2020-0041, an amendment to the Special Use Permit is required. The Planning Commission is authorized to approve an amendment to a Special Use Permit.

RECOMMENDED MOTION: "I move to approve LU-2020-0051 based on the ability to make the required findings and subject to the conditions of approval included in the staff report."

Note: The base language in these conditions is the language from the conditions of approval approved on November 17, 2020 with LU-2020-0041. Language proposed to be added appears in bold with an underline. Language proposed to be deleted appears with a strikethrough.

- 1. All development shall be substantially in accordance with the approved plans, except as otherwise modified by the conditions of approval.
- 2. All on and off-site improvements shall conform to City standards and requirements.
- 3. The use for which this permit is approved shall commence within twelve (12) months of the date of final approval. A single, one (1) year extension of time must be requested in writing to the Planning and Community Development Department thirty (30) days prior to the one (1) year expiration date. Should this permit not be initiated within one (1) year and no extension granted, the permit shall become null and void.
- 4. The applicant must sign and return the Notice of Decision for conditions of approval within ten (10) days of receipt of notification. If the Notice of Decision is not signed and returned within ten (10) days, then the item may be rescheduled for the next Planning Commission meeting for further consideration.
- 5. Building materials shall be consistent with the approved plans. All exposed metal surfaces shall be painted in flat, non-glossy paint or an earth tone or muted color.
- 6. All exterior lighting must be directed downward. The design of the light standards must include cutoffs and shields, if necessary, to prevent spillover of light or glare onto adjacent properties.
- 7. The sidewalk to be removed and replaced along King Street must be 6.5 feet wide and the replacement must be extended approximately 45 feet to the east where the sidewalk widens to 6.5 feet in order to match the sidewalk in this area of the frontage and to accommodate high volumes of pedestrian traffic.
- 8. <u>Scheduled testing of the generator shall be scheduled for mid-afternoon on a weekday so as to blend with ambient noise.</u>
- 9. The existing chain link fencing with slats that surrounds the equipment yard must be maintained and slats replaced if missing.

- U-91/92-4: A Special Use Permit to allow for the placement of 4 portable classroom buildings at the Carson Middle School. Approved by the Planning Commission on July 30, 1991.
- U-93/94-5: A one-year review of a previously approved Special Use Permit to allow for the placement of two portable buildings at the Carson Middle School.
- U-94/95-55: A review of a previously approved Special Use Permit to allow the placement of two portable classroom buildings at the Carson Middle School.
- U-99/00-45: A Special Use Permit to allow for the installation of a freestanding reader board sign at the Carson Middle School. Approved by the Planning Commission on June 28, 2000.

 of the existing Carson City School District Office. Approved by the Planning Commission
 on November 17, 2020.

DISCUSSION:

The subject property is approximately 18.56 acres in size and is the site of the Carson Middle School and District Office. The site includes the main school building, operations building, two maintenance buildings and the district office building and maintenance yard, associated parking, and the track. The site is surrounded by single family residences.

On November 17, 2020 the Planning Commission approved a Special Use Permit for a 975 square foot addition and remodel to the existing District Office (LU-2020-0041). Since this approval, the applicant has determined the addition of a backup generator will be beneficial to provide power to the District Office for 24 hours in the event of a power outage. The generator is proposed to be located approximately 25 feet north of the District Office in the existing equipment yard. The generator will be screened by the existing slatted chain-link fence and will be installed within a sound attenuated weather protective enclosure. Per CCMC 18.04.170, the use may only be established or modified subject to a Special Use Permit. Since the generator was not contemplated as part of LU-2020-0041, an amendment to the Special Use Permit is required. The Planning Commission is authorized to approve an amendment to a Special Use Permit.

PUBLIC COMMENTS:

Public notices were mailed to 264 property owners within 600 feet of the subject site on March 12, 2021. As of the writing of this report, staff has not received any written comments. Any comments that are received after this report is completed will be submitted to the Planning Commission prior to or at the meeting on March 31, 2021 depending on the date of submission of the comments to the Planning Division.

OTHER CITY DEPARTMENTS OR OUTSIDE AGENCY COMMENTS:

Plans were routed to commenting agencies, and the following comments were received. Comments have been incorporated into the conditions of approval, as appropriate.

Engineering Division

The Engineering Division has no preference or objection to the special use request provided that the following conditions are met:

- The conditions of approval from the original submittal still apply.
- The project must meet all Carson City Development Standards and Standard Details.

The Engineering Division has reviewed the application within our areas of purview relative to adopted standards and practices and to the provisions of CCMC 18.02.080, Conditional Uses.

The Engineering Division offers the following discussion:

C.C.M.C. 18.02.080 (5a) - Master Plan

The request is not in conflict with any Engineering Master Plans.

C.C.M.C. 18.02.080 (5b) – Use, Peaceful Enjoyment, Economic Value, Compatibility Development Engineering has no comment on this finding.

<u>C.C.M.C.</u> 18.02.080 (5c) - Traffic/Pedestrians

Local intersections: The intersections surrounding the property is North Richmond Avenue, West King Street, West Musser Street and North Ormsby Boulevard. West King Street and North Ormsby Boulevard are minor collector streets while North Richmond Avenue and West Musser Street are local streets.

Parking and internal circulation: West King Street provides on street parking on both sides of the street while N Ormsby Boulevard has on street parking on one side of the street. North Richmond Avenue does not have on street parking but does provide a small parking lot. There is onsite parking. The internal circulation goes from West Musser St to W King Street.

C.C.M.C. 18.02.080 (5d) - Public Services

Sanitary Sewer:

The existing sewer main is 8-inch asbestos concrete pipe on the western and southern portion of the property. The main then transitions to 10-inch PVC pipe approximately 315 feet from the N Richmond Ave manhole on the southern portion of the property. These mains have sufficient capacity to serve the project.

Water:

The existing water main is 16-inch steel pipe to the west of the property while it is 12-inch
asbestos concrete pipe to the south of the property and a 6-inch cast iron pipe serves the
property. The water lateral is a 4-inch PVC pipe. These water mains have sufficient
capacity to serve the project.

Storm Drain:

• The properties open area drains to an on-site detention basin while the front of the property utilizes swales to drain to a storm drain on the corner of West King Street and North Richmond Ave. No additional mitigation is needed for stormwater runoff.

C.C.M.C. 18.02.080 (5e) – Title 18 Standards

Development Engineering has no comment on this finding.

C.C.M.C. 18.02.080 (5f) – Public health, Safety, Convenience, and Welfare

The project will meet engineering standards for health and safety if conditions are met.

- Earthquake faults: The nearest fault is over 1000 feet away with a slip rate of less than 0.2 mm/yr.
- FEMA flood zones: The flood zone is Zone X (shaded).
- Site slope: The site is already developed so the slope is minimal.
- Soils and Groundwater: The site is already developed.

C.C.M.C. 18.02.080 (5g) – Material Damage or Prejudice to Other Property

Development Engineering has no comment on this finding.

C.C.M.C. 18.02.080 (5h) – Adequate Information

The plans and reports provided were adequate for this analysis.

Fire Department

Project must comply with the International Fire Code and northern Nevada fire code amendments as adopted by Carson City.

Building Division

- 1. The project must be designed to the 2018 Code series.
- 2. The building permit must be submitted digitally to the Carson City Building Division at permitcenter.carson.org.
- 3. The building permit must include a site plan and specifications.

FINDINGS:

Staff's recommendation is based upon the findings as required by CCMC Section 18.02.080 (Special Use Permits) enumerated below and substantiated in the public record for the project.

1. Will be consistent with the objectives of the Master Plan elements.

The proposed backup generator for the Carson City School District Office is consistent with the Master Plan. The subject property is in the Public/Quasi-Public (PQP) master plan designation. The PQP designation is intended for schools, government offices, community centers, fire stations, airports, libraries, hospitals, and other similar uses. The project is proposed at the existing site of the District Office and will be used to support the District Office functions in the event of a power outage.

2. Will not be detrimental to the use, peaceful enjoyment, economic value, or development of surrounding properties or the general neighborhood; and is compatible with and preserves the character and integrity of adjacent development and neighborhoods or includes improvements or modifications either on-site or within the public right-of-way to mitigate development related to adverse impacts such as noise, vibrations, fumes, odors, dust, glare or physical activity.

The project will not be detrimental to the use, peaceful enjoyment, economic value, or development of surrounding properties or the general neighborhood. The proposed backup generator will be installed within the existing equipment yard. The generator will be screened by the existing, slatted, chain-link fence which surrounds the equipment yard. As part of the operations, the generator will be tested monthly for approximately 30 minutes. At 23 feet away from the source, the decibel level will be 73 decibels. This is approximately equivalent to the sound of a vacuum cleaner. The proposed location for the generator is interior to the subject parcel and located approximately 25 feet north of the District Office and approximately 246 feet from the nearest residence. To prevent the noise from being objectionable, staff recommends a condition of approval that testing be scheduled for a weekday, mid-afternoon. This would coincide with a time when ambient noise may be greater than in the morning or evening, thus causing any noise from testing to blend in with the background noise. Additionally, staff is recommending a condition requiring maintenance of the existing chain link fence with slats to ensure the generator will continue to be screened from view.

3. Will have little or no detrimental effect on vehicular or pedestrian traffic.

The addition of a generator to the site will not create a detrimental effect on vehicular or pedestrian traffic. There will be no change to traffic patterns.

4. Will not overburden existing public services and facilities, including schools, police

and fire protection, water, sanitary sewer, public roads, storm drainage, and other public improvements.

The addition of a backup generator will not overburden or create a demand on public services or facilities. It will allow the Carson City School District Office to continue to operate during power outages.

5. Meets the definition and specific standards set forth elsewhere in this Title for such particular use and meets the purpose statement of that district.

The primary purpose of the Public zoning (CCMC 18.04.170) is to accommodate a wide range of public institutional and auxiliary uses including but not limited to, buildings and facilities owned, leased or operated by the City, Carson City Unified School District, or any other district, the State of Nevada or the federal government. The addition of a backup generator to the remodel project for the Carson City School District Office is consistent with this purpose. Per CCMC 18.04.170 the use may only be established or modified subject to a Special Use Permit. In the P zoning district, setbacks and heights are determined as part of the special use permit. As conditioned, the project will meet the definition and specific standards set forth in Title 18.

6. Will not be detrimental to the public health, safety, convenience and welfare.

The backup generator will not be detrimental to the public health, safety, convenience and welfare. The generator will allow the District Office to continue to operate during power outages.

7. Will not result in material damage or prejudice to other property in the vicinity, as a result of proposed mitigation measures.

The site currently operates as the District Office and Carson Middle School and contains office buildings, maintenance buildings, school buildings, and operations buildings. The site is immediately adjacent to single-family residences on all sides. The proposed generator, subject to the conditions of approval, will not result in material damage or prejudice to other property in the vicinity. As noted, staff was concerned with noise impacts; however, with the installation including a noise attenuating enclosure and a condition limiting scheduled testing to mid-afternoon on a weekday, it will not result in material damage or prejudice to other property in the vicinity.

- c. Vicinity map must be shown on the site plan. This is a map, not to scale, that you would provide a visitor unfamiliar with the area as directions to get to your property. It will show adjacent streets.

 - The name, mailing address, and daytime phone number of the <u>person preparing the site plan</u>, if different from applicant.
 - The name, mailing address, and daytime phone number of the record owner of the subject property, if different from applicant.
 - iv. Assessor Parcel Number(s) (APN) and address (location, if no address) of the subject property.
 - v. Project title and permit request. (Example: Variance, Special Use Permit).
- 8. Property lines of the subject property with dimensions indicated.
- 9. All existing and proposed structures shall be shown, including:

APPLICATION REQUEST

The enclosed application is for:

 An amendment to SPECIAL USE PERMIT LU-2020-0041 to provide a back-up generator for the Carson City School District's District Office Building. The SUP LU-2020-0041 Notice of Decision and Conditions of Approval are attached for reference. This is an administration building and is an accessory use to a School, which is a conditional use in a Public (P) zoning designation (CCMC Section 18.04.170(3)).

PROJECT LOCATION

The existing District Office is located at 1402 W. King Street. It is one of several structures on this 18.56 acre site, the main structure being the Carson Middle School. The APN is 003-171-01. The District Office is located on the north side of King Street between N. Ormsby Blvd. and N. Richmond Ave., directly across from Carville Circle. The back-up generator will be located on the north side of the district office in an existing equipment yard behind an existing 6' high chain link fence with sight obstructing slats.

Figure 1: Project Location





PROJECT DESCRIPTION

The proposed back-up generator is self-contained and is approximately 6'W x 15'L x 10'-6"H and will sit on a new concrete pad above ground. It will be located in an existing equipment yard to the north of the District Office. Access to the back-up generator will be provided via an existing paved access road on the north side of the District Office through an existing vehicle gate. The equipment yard is surrounded on two sides by buildings and on the other two sides by chain link fencing with privacy slats. Access to the equipment yard is limited to CCSD personnel. The generator is sized to provide power to the district office building for 24 hours in the event of a power outage.

The Carson City Municipal Code does not set Development Standards in the Public zoning district (Section 18.04.195). Building height, building setbacks, minimum area, minimum lot depth and minimum lot width are determined by special use permit. There is no impact to minimum area, lot depth or lot width and building setbacks are not a factor since the back-up generator is located on the interior portion of the parcel.

The generator will be set behind an existing 6' high chain link fence with sight obstructing slats to allow for adequate screening. Additionally, the equipment is located in an existing equipment yard that is interior to the site, so it will not impair sight distances and is not visible from the adjacent public right-of-way which meets the intent of the Carson City Development Standards, Section 1.2.9 for typical screening of service areas.

No additional landscaping or landscape protection measures are required since the back-up generator and concrete pad will be located where there is currently asphalt pavement so there is no additional impervious area.

FINDINGS

In accordance with the Carson City Municipal Code Sections 18.02.080(5), this project is designed to consider the following:

Findings from a preponderance of evidence must indicate that the proposed use:

- 1. Will be consistent with the objectives of the Master Plan elements.
 - A back-up generator to serve the CCSD District Office is consistent with the objectives of the Carson City Master Plan elements because it improves an existing public facility. The Master Plan Policy Checklist is included in this application package along with additional information.
- 2. Will not be detrimental to the use, peaceful enjoyment, economic value, or development of surrounding properties or the general neighborhood; and is compatible with and preserves the character and integrity of adjacent development and neighborhoods or includes improvements or modifications either on-site or within the public right-of-way to mitigate development related to adverse impacts such as noise, vibrations, fumes, odors, dust, glare or physical activity.

The back-up generator is proposed to serve an existing building in the event of a power outage. The surrounding neighborhood is comprised of single-family residential housing. The generator will be located behind a fence with sight obstructing slats in an existing equipment yard on the interior of the site, so the project will not have additional impact or be detrimental to the use, peaceful enjoyment, economic value, or development of surrounding properties of the neighborhood.

There is no outdoor lighting proposed for the back-up generator, so there will be no impact to neighboring property due to glare.

3. Will have little or no detrimental effect on vehicular or pedestrian traffic.

There will not be an increase to vehicular or pedestrian traffic as indicated in the Project Impact Reports.

4. Will not overburden existing public services and facilities, including schools, police and fire protection, water, sanitary sewer, public roads, storm drainage and other public improvements.

The CCSD District Office is an existing use. The installation of a back-up generator will help temporarily restore power to the district office for up to 24 hours in the event of a power outage, therefore the project will not overburden existing public services and facilities. Water, sanitary sewer, public roads and storm drainage will not be impacted as indicated in the Project Impact Reports.

5. Meets the definition and specific standards set forth elsewhere in Carson City Municipal Code, Title 18 for such particular use and meets the purpose statement of that district.

A school is a conditional use in a Public (P) zoning designation (CCMC Section 18.04.170(3)). A school is defined as "an institution of learning which offers instruction in the several branches of learning required to be taught in public and private schools of the State of Nevada" (CCMC Section 18.03.010). The District Office, part of the Carson City School District, meets the definition of an accessory use as "a use of land that is associated with and dependent upon the existing permitted or conditional use of that parcel." (CCMC Section 18.03.010). The District Office is an accessory use to the conditional school use. It is existing in this location and the facility will be improved through this project.

6. Will not be detrimental to the public health, safety, convenience and welfare.

The installation of a back-up generator for the existing CCSD District Office will benefit the public health, safety, and welfare by providing an upgraded facility to the Carson City School District employees and public.

7. Will not result in material damage or prejudice to other property in the vicinity, as a result of proposed mitigation measures.

The CCSD District Office is an existing use in the neighborhood. The improvements to the facility will not result in material damage or prejudice to other property in the vicinity.
