No. 2021-R-____, authorizing expenditures of \$239,873 in total funds for community support services grants ("CSSG") to non-profit organizations and the Quality of Life

Initiative for Fiscal Year ("FY") 2022. (Mirjana Gavric, MGavric@carson.org)

Staff Summary: NRS 244.1505 requires that any funds granted by the Board of Supervisors to private, non-profit organizations be made by resolution. For FY 2022, the total CSSG funding for the adult and youth competitive category is \$124,480. Staff recommends funding of \$98,103 to be awarded for adult programs and \$21,770 to be awarded for youth programs. Staff further recommends that \$120,000 to be awarded to the Boys and Girls Club of Western Nevada in accordance with the Quality of Life initiative.

Background/Issues & Analysis

The CSSG program is able to award \$244,480 from the General Fund to non-profit organizations that address a critical need in Carson City. The amount of \$98,103 in funding is available through a competitive grant process for adult programs and \$26,377 is available through a competitive grant process for youth programs. Despite advertising by both Carson City and Partnership Carson City, youth programs only received two applications. In order to retain the competitive nature of these grants, staff recommends that the remaining \$4,607 in the youth program category be placed back into the General Fund for CSSG FY 2023. In addition, \$120,000 will be awarded to the Boys and Girls Club of Western Nevada from the Quality of Life Initiative.

A RESOLUTION AUTHORIZING THE DISBURSEMENT OF COMMUNITY SUPPORT SERVICES GRANT FUNDS TO NON-PROFIT ORGANIZATIONS FOR FY 2022

WHEREAS, NRS 244.1505(1) provides that the Board of Supervisors may grant money to private, not for profit organizations; and

WHEREAS, NRS 244.1505(3) provides that such grants must be made by a resolution which specifies the purpose of the grant, the maximum amount to be expended from the grant, and any other conditions upon the expenditure; and

WHEREAS, the Board of Supervisors has approved the expenditure of funds for community support services grants, the City has received applications for those grant funds, and the Board of Supervisors has determined that the disbursement of the grants to the private, not for profit organizations that are listed below will give a substantial benefit to the inhabitants of Carson City;

NOW, THEREFORE THE BOARD OF SUPERVISORS RESOLVES THAT:

1. For FY 2022, the following groups are granted the following amounts for the following purposes:
