My name is Michelle Pedersen. I am writing to show my support of considerable funding towards improvements at Governor's Field Sports Complex. This is my 14<sup>th</sup> year as a member of the Carson City Little League family. I have had 4 kids move through the program, coached for 10 years, and am currently in my 9<sup>th</sup> & final year as a board member, having served in the position of President for several years, Vice President for a few, Scheduler, Secretary, and Communications Officer.

As a board, we have poured thousands and thousands of league dollars into the complex over the past decade. All the way back to the planning & execution of building the Indoor Facility in 2010. In just the past 5 years, we have done a complete teardown and rebuild of the Field 3 dugouts (\$25,000), we've installed new carpet in all six score booths (\$3,000), we have repainted the snack bar (\$2,500), we have purchased and installed new scoreboards on 5 of the 6 fields (\$7,000 each = \$35,000), we renovated the dugouts on the TBall fields, giving them sun/wind protection (\$5,000), we purchased/installed new slats for the outdoor batting cages, and countless other minor facility improvements as they've come to our attention. We have had a wonderful operating relationship with the Parks and Rec Department, especially Dan Kastens, Lane Pickel, and Dave Navarro. In addition to the League-funded improvements, we've been able to be a part of several other major improvements, funded by the city. Through this relationship, our complex has gained a reputation throughout Northern Nevada baseball as the pride of the district. We are annually tasked with hosting regional and state Little League tournaments due to the unmatched prestige of Governor's Field.

In November 2020 the city released the results of a facilities study where 149 city-owned buildings and structures were rated. Of those, only three were said to be in very poor condition and in need of full demolition/rebuild. Two of those are in our complex – the Field 1 dugouts, and the Field 3 score booth. In addition to those failing structures, Field 3 has been a major source of challenge for the Parks and Rec field crews. It has poor drainage, many divots, lips and potholes, and it is not level. I know the Parks crew could give a better technical assessment of this, but as 'just a mom' who has given her whole self to the betterment of the complex & success of CCLL for the past 14 years, I can assess that Field 3 is soggy, dangerous and more often than not, unfit for play. In fact, as this year's Scheduler, I have made it a priority to not use Field 3 for games, except when unavoidable. And in instances where it must be used, we put the littlest players on it to minimize any outfield action. If Covid had not caused a 50% drop in registration this season, we could not have safely housed our league this year. Next season, at full capacity, I am extremely nervous about safely fitting all 50+ teams in the complex when one of the fields is unsafe.

On behalf of the entire CCLL Board, I urge the BOD to strongly consider a generous allotment of funds for the improvement of the three main areas of concern in Governor's Field – the Field 1 dugouts, the Field 3 booth, and the Field 3 turf. We have made continual effort to ensure the beauty and functionality of Governor's Field remains, but at this point, without the city's generous financial backing, this jewel of the district will begin to lose its luster. Please strongly consider going above and beyond the usual upkeep funding and provide enough financial resources that these three highly unsafe deteriorations can be repaired, and we can return to a fully safe and functional complex for the 600+ Carson City youth that we serve each Spring.

My name is Kristine Wymore and I am the acting Secretary, and Board Member, for the Sierra Junior Tennis Association. We are a local non-profit that works to provide charitable and educational programs to promote the development of junior tennis as a means of healthful recreation and physical fitness in the Northern Nevada/Lake Tahoe region. We are dedicated to growing junior tennis. I am in complete support of the budget proposed for the reconstruction of four courts at Centennial.

Sierra Junior Tennis Association (SJTA) formerly Biggest Little Tennis Association (BLTA) used to hold a number of local tournaments and “jamboree” (free days) at the Centennial site. However, since the courts have fallen into such disrepair, we have been unable to move ahead with any activities out of concern for our participant’s safety.

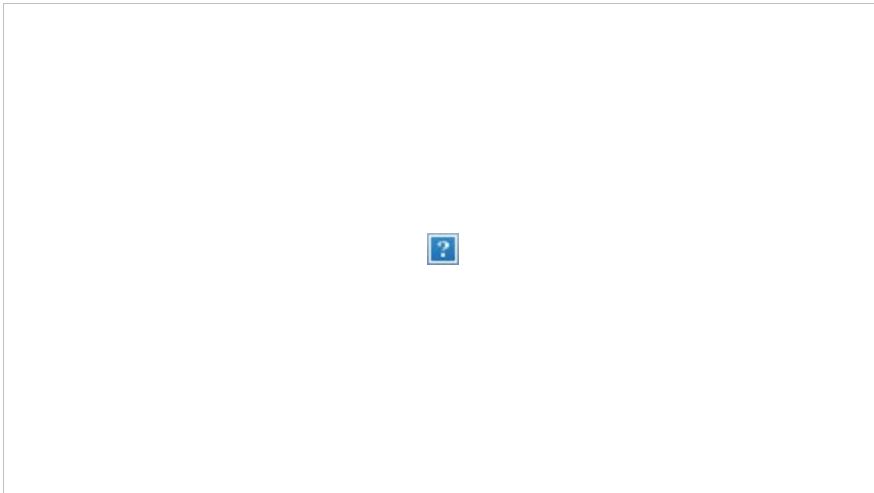

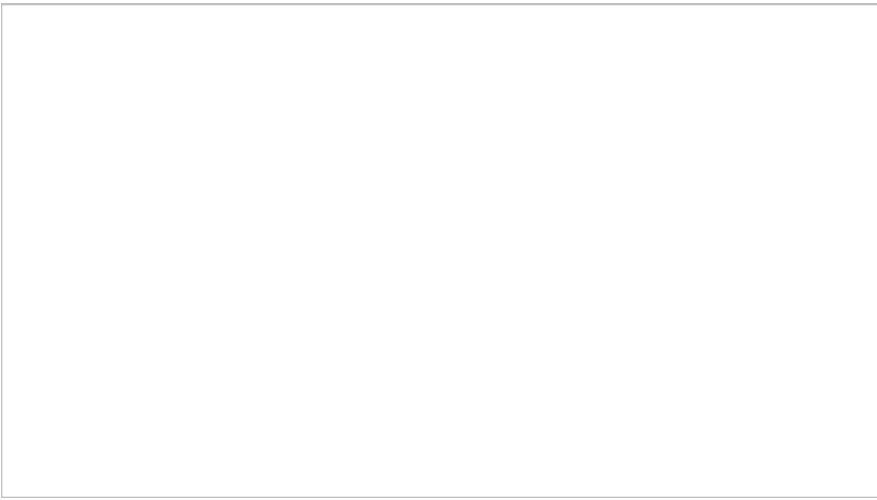

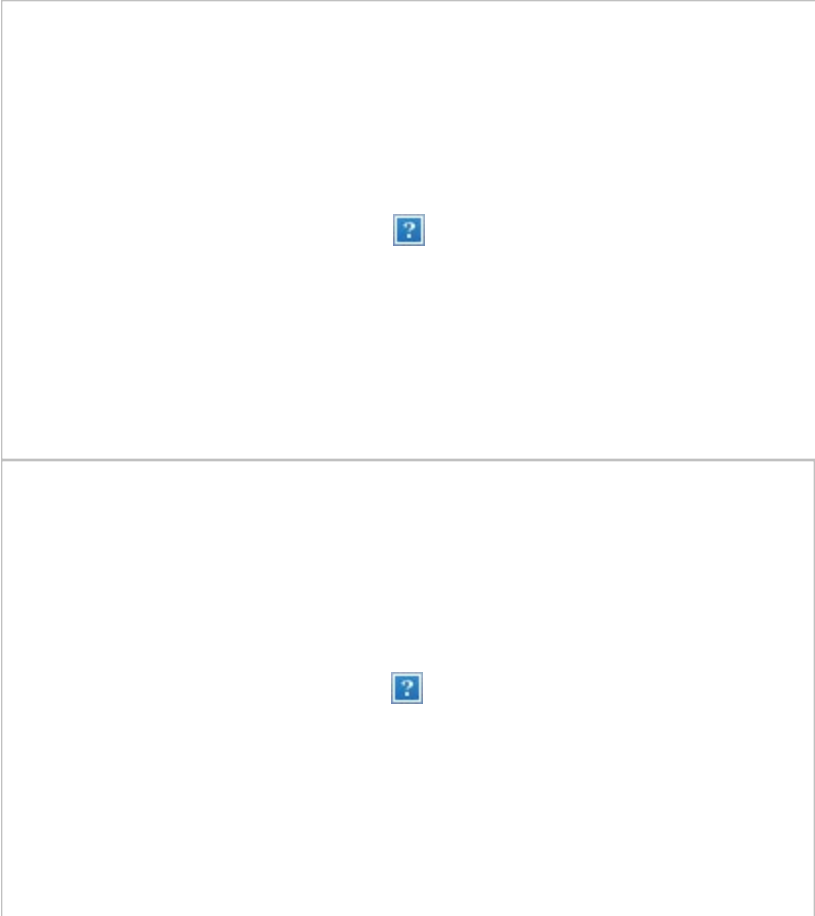

My name is Eldon Wilson I am writing in support of the budget proposed for reconstruction of four tennis court surfaces at the Centennial Tennis Courts. In my years in the industry I have supported many city programs along with Tennis Associations and understand the work it takes to make these programs strong and beneficial to their communities. As a retired tennis coach of over 45 years, when I moved to Northern Nevada I found hardly any tennis programs for juniors or adults. Coming from a National Coaching and United States Professional Tennis Association (USPTA) Elite Tennis Professional background and being a former Tennis Director with many Clubs as well as Community Tennis Associations (Antelope Ca was my last Community work) I found it sad that the courts were in such bad shape for the community. Finding the courts at Centennial and meeting a few tennis players, I became involved in a small way with some players in the community. Over the years talking with many of the Carson Tennis Association members and finding out more about the facility, I see some big opportunities for Carson City and surrounding areas where tennis is concerned. We all know there is a large influx of people moving into our wonderful area. I believe many of these folks are or could be tennis players if they had the facilities and opportunity to play.

Here are a few ways we as tennis players can give back to the community and you as a board for the financial support.

- The United States Tennis Association (USTA) has partnered with countless organizations, cities and universities around the nation in their quest to grow the sport of tennis. We can get support from the USTA for the rebuilding of the courts (the amount of support will depend on the amount of courts being rebuilt). For the USTA growing the game means income from memberships, tournaments and adult leagues etc... not to mention schools' programs for juniors.
- Income through programs to the City: Junior Tennis Tournaments (I am also a USTA tournament Director) can bring in as much as \$7,500.00 (minus cost to run the event), along with income to the city from expenses like motels, meals, shopping etc. Also, Junior and Adult programs can bring in a percentage of proceeds to the City.
- In time, starting a Tennis Association again would give support to the city which could help with general maintenance of the courts and out building along with some maintenance costs.

The new courts would give the old and new residents of Carson City a place to come and meet others and play a great sport.

It is my hope that if the funding request is approved, it will be leveraged as match for an additional grant from the Land and Water Conservation Fund and the USTA and/or a private foundation so potentially all eight courts could be reconstructed at the same time. 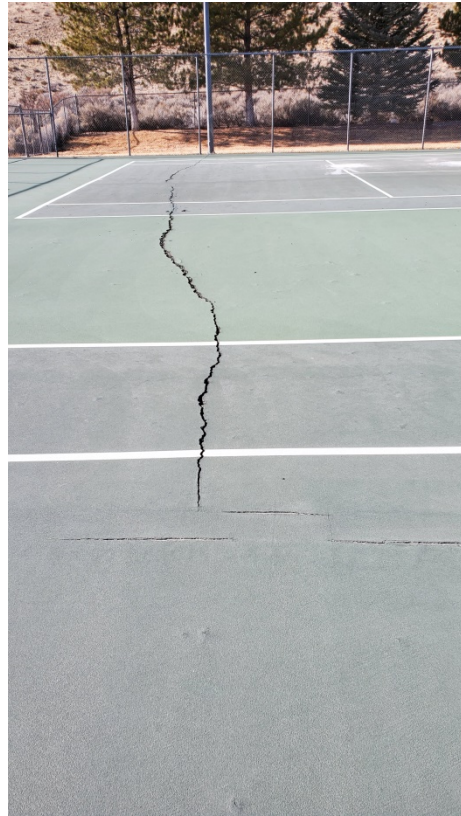

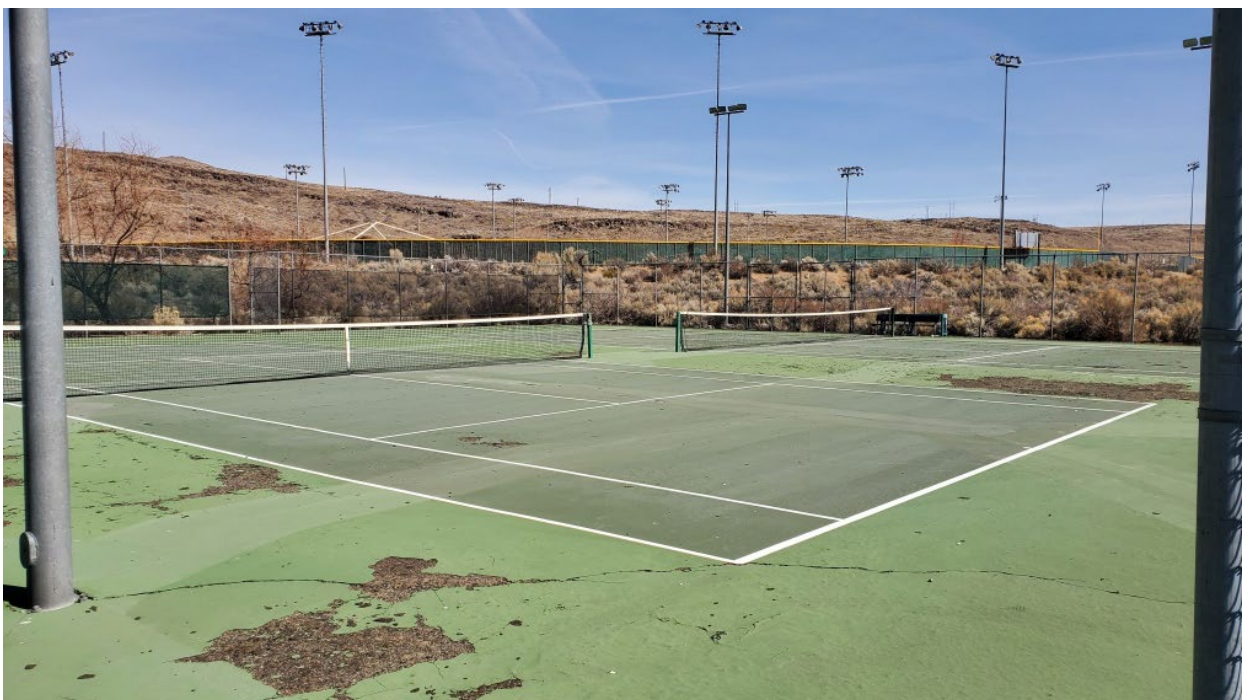

News reports have characterized this as the possible development of affordable/workforce housing located at 3410 Butti Way.

"Affordable/workforce housing" seems to be quite the buzzwords in Council chambers all across Nevada, these days. What I have seen of similar projects, they typically turn out to be either government subsidized housing with low-income qualification (sometimes referred to as Section 8 housing) or income restricted housing (with gross income limits at about \$25,000-\$30,000 per year for HUD projects).

I wish for the members of the Council to consider that, with median home prices in Northern Nevada now approaching ten times the gross median earnings of our citizens (around \$50,000) there is a significant gap in what is affordable and the available wages that are being paid in this region.

There are plenty of housing projects around this region already built or in the works that are income restricted or Section 8, and that serve those with \$25,000-\$35,000 annual gross income.

If we were to help get more housing in Carson City that is affordable to the median income earners, that housing would be in the \$200,000 to \$300,000 range for detached homes and \$100,000 to \$180,000 for duplexes and condominiums.

Members of Council could stimulate local job creation as well as create the sort of housing that would be affordable to the typical working class citizen, by offering the land for sale to local builders with conditions on the type of housing to be built. We need something along the lines of the Levittown development in New York after WWII: Small, economically priced houses that can be bought by working class citizens; without some government bureaucrat picking winners and losers based on some contrived criteria born in Washington D.C.

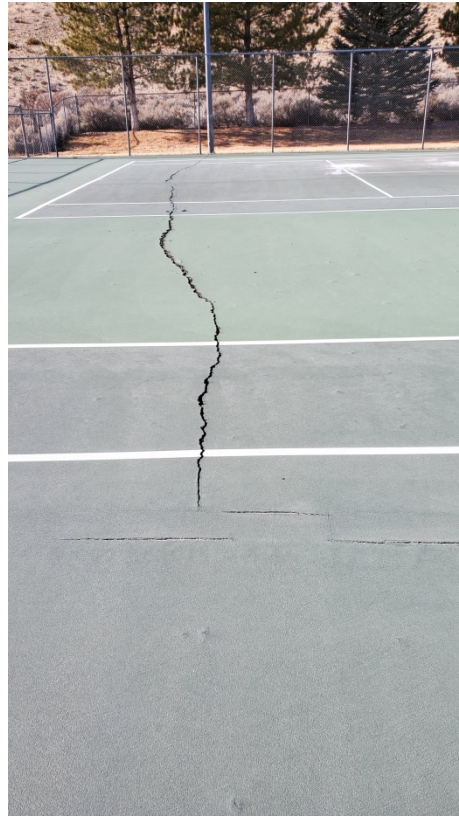
