## RESOLUTION NO. 2021-R-\_\_

A RESOLUTION PASSING UPON THE MERITS OF ALL COMPLAINTS, PROTESTS AND OBJECTIONS TO THE ESTABLISHMENT OF THE SOUTH CARSON NEIGHBORHOOD IMPROVEMENT DISTRICT FOR THE MAINTENANCE OF THE SOUTH CARSON STREET COMPLETE STREETS PROJECT.

**WHEREAS**, the Carson City Board of Supervisors ("Board") initiated the process to establish the SCNID on April 15, 2021, pursuant to NRS Chapter 271, to help pay for the ongoing maintenance of the South Carson Street Complete Streets Project; and

**WHEREAS**, notice of the proposed South Carson Neighborhood Improvement District ("SCNID") was duly published, posted, and mailed to all property owners within the proposed SCNID in accordance with the provisions of NRS 271.305; and

**WHEREAS**, the Board conducted a public hearing on May 20, 2021, to hear all complaints, protests and objections to the establishment of the SCNID.

# **NOW, THEREFORE,** the Carson City Board of Supervisors resolves that :

- 1. In accordance with NRS 271.310 and 271.320, all complaints, protests and objections to the proposed SCNID as presented at the public hearing for such matters on May 20, 2021 are hereby considered, passed upon and disposed of.
- 2. The City is not prevented from proceeding with the establishment of the SCNID pursuant to NRS 271.306 subparagraphs (3) or (4).
- 3. There were not filed with the Clerk any complaints, protests and objections in writing and signed by the owners of tracts constituting a majority of the frontage or of the area of the tracts to be assessed in the SCNID, and the governing body has jurisdiction to proceed.
  - 4. The City shall proceed with the SCNID.
