Agenda Title: For Possible Action: Discussion and possible action regarding authorization for the submission of an application for grant funding in the amount of approximately \$375,000 from the Nevada Office of Criminal Justice Assistance, Coronavirus Emergency Relief Supplemental Funding, for the acquisition of Carson City Sheriff's Office ("CCSO") technology. (Jerome Tushbant, jtushbant@carson.org)

Staff Summary: This grant would provide funds to increase the ability for CCSO to respond to current and future crises as well as to create efficiencies and ensure safety through the use of technology. This application will include a request for approximately 77 Panasonic CF-33 tablets and associated hardware, as well as infrastructure improvements to approximately 50 vehicles. This grant is on a "first come first serve basis" with an estimated amount to be requested of \$375,000.

Background/Issues & Analysis

CCSO currently has Panasonic CF-31 computers, often referred to as "MDC's", in almost all first response vehicles. These computers are vital to communications, records inquiries, and report writing. The current MDC's are aged and nearing end of life. This technology is vital to efficiency and officer safety. The old CF-31 is a single computer which remains mounted in a vehicle. This causes issues of exposure to numerous employees throughout a short period of time. The result is the potential for infectious disease cross contamination. To address this issue an improvement to the existing technology, a CF-33 which is a rugged detachable 2-in-1 device, will allow for removal of the computer and assignment to individual deputies reducing transfer of contaminants and improving efficiency. Additionally, these new computers will allow for remote work so that deputies can take crime scene photographs directly from the MDC's as well as use the device away from the vehicle. The CF-33 is already being tested by CCSO and the Carson City Information Technology Department; the computer is commonly used by other law enforcement agencies. If approved by the Board of Supervisors and the Grantor, this technology will prepare the office for future challenges and improve efficiency as well as safety.

The Office of Criminal Justice Assistance (OCJA) has federal funding for Coronavirus Emergency Relief Supplemental Funding (CESF). This funding is available for those agencies with a criminal justice nexus to prevent, prepare for, and respond to Coronavirus Disease 2019 (COVID-19).

Agencies with a criminal justice nexus could include but are not limited to:

- Public Defenders*
- Courts, both adult and juvenile
- Local Law Enforcement
- Detention Centers both adult and juvenile

*Public Defenders that are contracted by the County, must reach out to the County or County Sheriff to apply for this funding

Grant Awards will be made on a **First Come First Serve Bases**.

OCJA has received and funded CESF applications. The following list of projects are based on those applications. OCJA has also talked to local agencies over gaps that may not only assist them through this crisis but prepare them for a future crisis, as well as create efficiencies and safety through technology. The National Criminal Justice Association has also provided OCJA with some examples that are ever changing as other states tackle the same issues.

These projects could be, but are not limited to:

- Virtual Jail Visitation for family and confidential attorney/client visits. The reduction of in-person visitation reduces potential for COVID19 transmission and spread.
- Public Hearings through YouTube or another platform.
- Technology resources such as cell phones, laptops, video conference licensing, and virtual private network (VPN) to allow telework, if necessary.

- **Personal Protective Equipment (PPE) to protect against the spread of COVID-19, such as sanitizer and masks.**
- **Technology for video arraignment and virtual services. This could include technologies to provide a virtual court system with a link to the detention center. The benefit of this project will allow the courts to provide essential hearings and mandated commitments. By linking them to the various detention centers, the detention center may be relieved of transporting inmates. Not moving inmates, creates safety of exposure for both the officer and the inmate. Other stakeholders could include prosecuting and/or defense attorneys.**
- **Virtual/Safety for detention centers (adult and juvenile). This could include, jail security cameras, intercom system, door controls, visitation booth for privacy and security of professional visits, equipment for sanitation, and video court. This must be tied to remote supervision to ensure the safety of the officer and inmate by limiting exposure.**
- **Supervision technology via tele-supervision that facilitate monitoring early release/re-entry as the result of COVID 19. These technologies could include monitoring ankle bracelets, check-in kiosks, ZOOM, Webex, to name a few. Many correctional facilities are using specially developed Smart Phone Apps such as tracktech. These apps can be loaded on the client's phone or a phone could be provided by the agency. These apps offer many benefits and have been proven to provide promising results. They provide GPS tracking, check-in (either scheduled or random), calendar appointments, and can be tethered to a bracelet for higher risk clients.**
- **Specially designed decontamination equipment for vehicles, facilities, and equipment. Depending on the agency these products have been shown to be highly effective against all viruses and have been proven to cost effective.**

These are just a few ideas that may spark an idea of a gap created by the outbreak of COVID 19. OCJA is here to assist you and welcomes conference calls between multiple stakeholders for a larger project.

In addition, I am pleased to announce the appointment of Michelle Hamilton (775) 687-1503 or mehamilton@dps.state.nv.us to manage applications for the CESF grants. All evaluations as to availability and eligibility of CESF funds will be screened by myself and this office. Should they meet CESF criteria they will be awarded promptly.
