RESOLUTION CONSENTING TO RELINQUISHMENT
AND LAND TRANSFER AGREEMENT

WHEREAS, the State of Nevada, Department of Transportation, hereinafter called the Department, desires to relinquish all of SR-518 (Snyder Avenue) lying within Carson City, State of Nevada, extending from the easterly right-of-way line of SR-529 (Carson Street) at approximate Highway Engineer's Station "SY" 27+00.00 P.O.T. to approximate Highway Engineer's Station "SY" 76+74.03 P.O.T., a distance of approximately 1 mile, said right-of-way is delineated and identified as Parcel S-518-CC-000.040 RT1 on EXHIBIT "A" attached hereto and made a part hereof; and

WHEREAS, the Carson City Board of Supervisors desires that the aforesaid highway be relinquished to Carson City; and

WHEREAS, Carson City has requested the relinquishment of aforesaid highway for the purpose of a transportation facility; and

WHEREAS, Carson City has agreed to accept the relinquishment of said right-of-way for the aforesaid SR-518 (Snyder Avenue) together with any and all revocable leases and licenses entered into between the Department and the adjoining owners for the multiple use of the right-of-way.

NOW THEREFORE be it resolved that the Carson City Board of Supervisors does in consideration of the actions of the Department as set forth herein, hereby consent to the State of Nevada, Department of Transportation, Board of Directors, relinquishing to Carson City, all of SR-518 (Snyder Avenue) lying within Carson City, State of Nevada, extending from the easterly right-of-way line of SR-529 (Carson Street) at approximate Highway Engineer's Station "SY" 27+00.00 P.O.T. to approximate Highway Engineer's Station "SY" 76+74.03 P.O.T., a distance of approximately 1 mile, said right-of-way is delineated and identified as Parcel S-518-CC-000.040 RT1 on EXHIBIT "A" attached hereto and made a part hereof.

The parties acknowledge that no relinquishment can occur until the Department of Transportation, Board of Directors approves of this relinquishment.

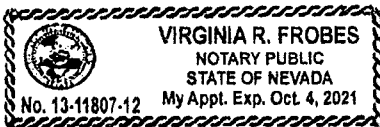

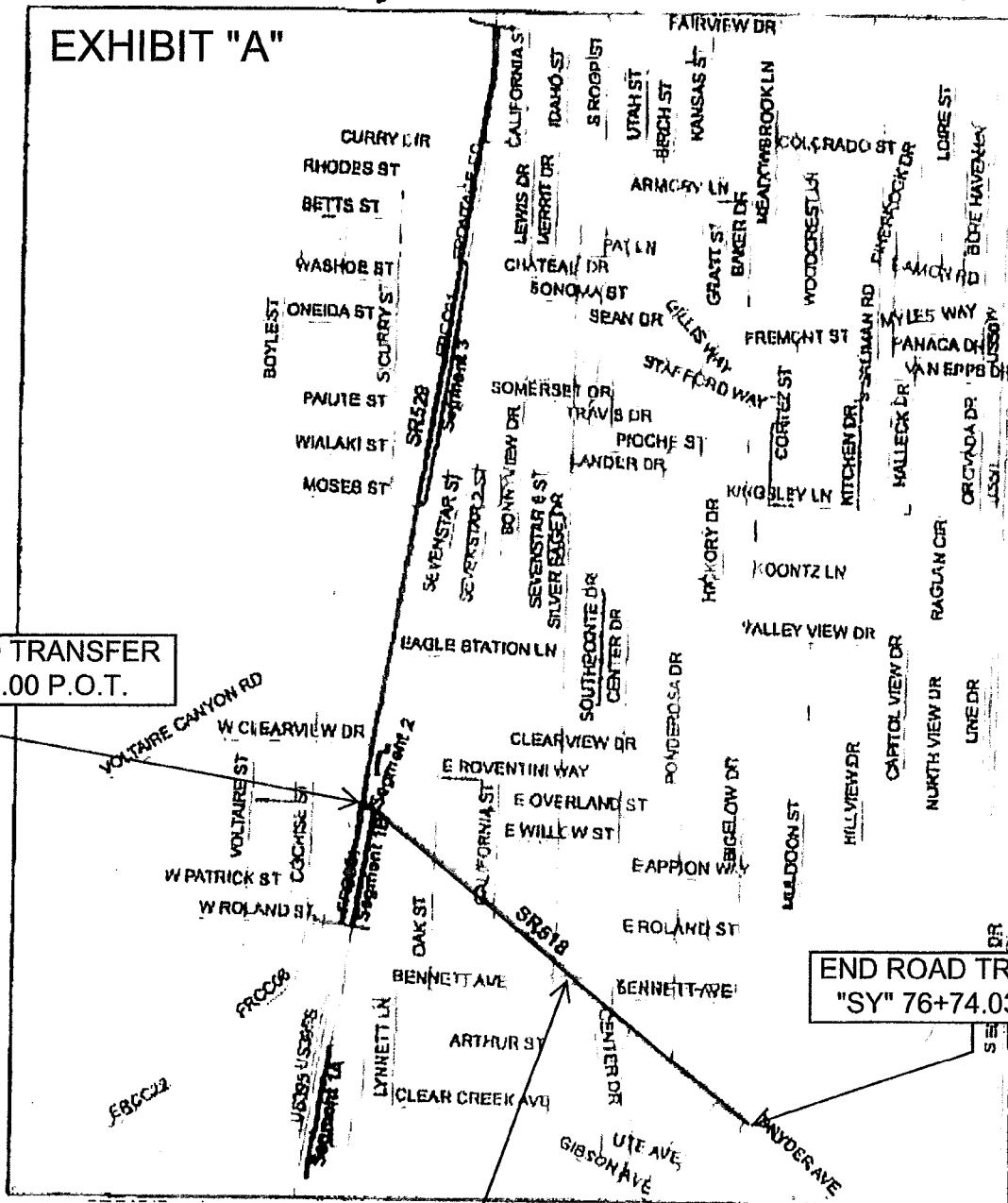

**RESOLUTION OF RELINQUISHMENT
OF A PORTION OF STATE HIGHWAY RIGHT-OF-WAY**

WHEREAS, the State of Nevada, Department of Transportation, hereinafter called the Department, presently holds a fee simple interest in that certain right-of-way for portions of SR-518 (Snyder Avenue) , extending from the easterly right-of-way line of SR-529 (Carson Street), at approximate Highway Engineer's Station "SY" 27+11 P.O.T. to the northerly right-of-way line of IR-580, at approximate Highway Engineer's Station "SY" 52+23 P.O.T., and from the southerly right-of-way line of IR-580, at approximate Highway Engineer's Station "SY" 57+47 P.O.T. to the east sixteenth section line of Section 32, T. 15 N., R. 20 E., M.D.M., at approximate Highway Engineer's Station "SY" 76+74 P.O.T.; and

WHEREAS, said right-of-way is delineated and identified as Parcels S-518-CC-000.040 RT1 and S-518-CC-000.040 RT2 on EXHIBITS "A" through "H", inclusive,

attached hereto and made a part hereof; and

WHEREAS, as set forth in NRS 408.527, the Nevada Department of Transportation may, by resolution of the board, relinquish to cities and counties any portion of any state highway which has been superseded by relocation or which the Department determines exceeds its needs; and

WHEREAS, said right-of-way is of no further contemplated use by the Department due to portions of SR-518 (Snyder Avenue) being in excess of its needs; and

WHEREAS, Carson City has requested the relinquishment of aforesaid portion of highway for the purpose of a transportation facility; and

WHEREAS, the Carson City Board of Supervisors has agreed to accept the relinquishment of said right-of-way for the aforesaid SR-518 (Snyder Avenue) together with any and all revocable leases and licenses entered into between the Department and the adjoining owners for the multiple use of the right-of-way; and

WHEREAS, Carson City entered into an agreement with the Department on October 29, 2018 to accept the hereinafter described designated street as a part of Carson City street system; and

WHEREAS, the Board of Supervisors of Carson City, State of Nevada, consented by resolution passed and adopted on October 18, 2018 to the Department relinquishing the aforesaid portion of said street to Carson City; and

WHEREAS, NRS 408.527 provides that the Department of Transportation may relinquish any portion of a state highway which has been superseded by relocation or which the Department determines exceeds its needs after the Department and the city or county have entered into an agreement and the city or county legislative body has adopted a resolution consenting thereto.

THEREFORE, it is hereby determined by the Board of Directors of the Nevada

Department of Transportation, State of Nevada, that the following described right-of-way and incidents thereto, being all that land, delineated and identified as Parcels S-518-CC-000.040 RT1 and S-518-CC-000.040 RT2 on EXHIBITS "A" through "H", inclusive, attached hereto and made a part hereof, is hereby relinquished to Carson City of the State of Nevada. Said right-of-way is described as follows:

Situate, lying and being in Carson City, State of Nevada, and more particularly described as being portions of Section 32, T. 15 N., R. 20 E., M.D.M., and further described as being parcels of land, varying in width, from the easterly right-of-way line of SR-529 (Carson Street), at approximate Highway Engineer's Station "SY" 27+11 P.O.T. to the northerly right-of-way line of IR-580, at approximate Highway Engineer's Station "SY" 52+23 P.O.T., and from the southerly right-of-way line of IR-580, at approximate Highway Engineer's Station "SY" 57+47 P.O.T. to the east sixteenth section line of Section 32, T. 15 N., R. 20 E., M.D.M., at approximate Highway Engineer's Station "SY" 76+74 P.O.T.;


EXCEPTING THEREFROM any and all water rights appurtenant to said parcel.

SUBJECT TO any and all existing easements whether of record or not.




