final recommendation to the Nevada Governor's Office of Economic Development ("NGOED") on the Community Development Block Grant-COVID 19 ("CDBG-CV") to be granted to nonprofit organizations in the amount of \$173,298.54 for Fiscal Year ("FY")

2022. (Mirjana Gavric; MGavric@carson.org)

Staff Summary: The CDBG-CV provides funding for activities that respond to and prevent the spread of COVID-19. The Board of Supervisors ("Board") is required to make a final recommendation and approval of funding for CDBG-CV projects to NGOED. Carson City has received three rounds of funding for CDBG-CV. This report addresses the third and final round of funding which has a total remaining balance of \$173,298.54 available. Applications were solicited and four public service project applications were received, requesting a total of \$186,537. The Application Review Work Group ("AWRG") is recommending funding to the Ron Wood Family Resource Center in the amount of \$100,000; St. Vincent de Paul in the amount of \$18,000; Spirit of Hope Inc. in the amount of \$46,270.54; and Nevada Rural Counties RSVP Program, Inc. in the amount of \$9,028.

Previous Action

On September 17, 2020, the Board approved \$237,004 in awards from the CDBG-CV IA allocation.

On January 7, 2021, the Board approved \$151,382 in awards from the CDBG-CV IB allocation.

On June 3, 2021, the Board approved \$322,497.46 in awards from the CDBG-CV II & III allocations.

Background/Issues & Analysis

Carson City has received three CDBG-CV allocations: CDBG-CV I, in the amount of \$307,430; CDBG-CV II, in the amount of \$205,504; and CDBG-CV III in the amount of \$371,248, for a total amount of \$884,182. The following was previously awarded: on September 17, 2020, the amount of \$237,004; on January 7, 2021, the amount of \$151,382; and on June 3, 2021, the amount of \$322,497.46. This left an amount yet to be awarded of \$173,298.54.

In accordance with CDBG requirements, staff formed an Application Review Work Group (ARWG) to evaluate and rank the four applications received and to make funding recommendations based on community need, projected outcome, and compliance with State and HUD requirements. Applications were due on July 23, 2021. The ARWG held a Teams meeting on August 10, 2021, during which the ARWG ranked and evaluated the proposed program applications. The ARWG recommends that the Board fully fund the Ron Wood Family Resource Center for \$100,000.00 and St. Vincent de Paul for \$18,000.00. The ARWG recommends that the Board partially fund Spirit of Hope Inc. for \$46,270.54 and RSVP for \$9,028.00.

After the Board discusses, makes any desired amendments and approves the CDBG-CV awards, staff will forward the final approved recommendations to NGOED for consideration. This award, if approved, will be the final allocation for CDBG-CV Funds.

Subject: CDBG-COVID 19 Funding Proposals III

The Board of Supervisors is required to make a final recommendation and approval for the Community Development Block Grant-COVID 19 (CDBG-CV) programs to the Nevada Governor's Office of Economic Development (NGOED). Carson City has received three CDBG-CV allocations: CDBG-CV I, in the amount of \$307,430; CDBG-CV II, in the amount of \$205,504; and CDBG-CV III in the amount of \$371,248, for a total amount of \$884,182. This approval is for CDBG-CV III.

Due to the amount requested in the first round the application process was divided into four rounds: CDBG-CV 1A, CDBG-CV1B, CDBG-CV II& III and CDBG-CV III. The total amount funded for CDBG-CV1A, CDBG-CV1B and CDBG-CV II & III is \$710,883.46, leaving \$173,298.54 for the final application round, CDBG-CVIII.

The Application Review Work Group (ARWG) is making a recommendation to fund all four applications received for a total of \$173,298.54, which will fully allocate funding for the CDBG-CV funding I, II and III.

As part of the abbreviated CDBG Citizen Participation requirement, an online workshop session was held on June 17, 2021 to review the CDBG-CV requirements and application process. The request for applications was posted on Carson NOW, City Hall, Carson City Community Development office and the Carson City website. Applications were also solicited by e-mail to local community service organizations.

Applications were due on July 23, 2021. The ARWG held a Teams meeting on August 10, 2021, in which the ARWG ranked and evaluated the proposed program applications for community need, projected outcome, and compliance with State and HUD requirements. The ARWG consisted of 4 volunteers representing both community members and subject matter experts. These members are:

CDBG-CV III PUBLIC SERVICE PROGRAMS RECOMMENDATIONS:

1) **Project Name:** Family Support for COVID-19
Agency: Ron Wood Family Resource Center

Funding Request: \$100,000 **Recommendation:** \$100,000 **Applicant Score:** 85%

Objective: Serving low to moderate income (LMI) persons.

Description: Ron Wood Family Resource Center is requesting funds in order to help prevent potential eviction to families in the Carson City community as a direct result of the COVID-19 pandemic. This second round of funding, for this program, will allow Ron Wood to continue to provide "wrap-around" services to include utility assistance, counseling, education support, employment services and mental/physical health referrals.

Funding Recommendation Rationale: Approved under Section 105(a)(8) of the Housing and Community Development Act of 1974 (HCDA), provisions of public services. The ARWG is recommending full funding based on the amount of money received from CDBG-CV. The ARWG unanimously voted to support this request because this program will help Carson City families receive services that will help a wide variety of their needs.

2) Project Name: Emergency, Short-Term Housing for the Homeless

Agency: St. Vincent de Paul

Funding Request: \$18,000
Recommendation: \$18,000
Applicant Score: 79%

Objective: Serving low to extremely low income (LMI) persons.

Description: St. Vincent de Paul is requesting funding to provide emergency, short-term housing for the homeless population of Carson City. The goal is to prevent the possible spread of COVID-19 by paying for temporary housing to anyone who is denied access to a winter sleeping shelter due to COVID-19 symptoms and to anyone that has recently become homeless due to any COVID-19 circumstance.

Funding Recommendation Rationale: Approved under Section 105(a)(8) of the Housing and Community Development Act of 1974 (HCDA), provisions of public services. The ARWG is recommending full funding for this request, based on the funding available through CDBG-CV. The ARWG felt that the need for this request is essential to the recently homeless population of Carson City.

3) Project Name: Cleaning and Client Health Program

Agency: Spirit of Hope Inc.

Funding Request: \$49,309.00 **Recommendation:** \$46,270.54

Applicant Score: 78%

Objective: Serving low to extremely low income (LMI) persons.

Description: Spirit of Hope is requesting funds for a professional cleaner to deep clean each of their supportive homes, a licensed nurse to provide on-site checkups with residents 4 hours per week and one new staff to provide weekend management support for all homes.

Funding Recommendation Rationale: Approved under Section 105(a)(8) of the Housing and Community Development Act of 1974 (HCDA), provisions of public services. The ARWG is recommending partial funding for this request, based on the funding available through CDBG-CV. The ARWG felt that the need for this request is essential to the health and wellbeing of the clients being served. The request for a 12% indirect rate can't be funded because the grant cap is 10%; therefore, the ARWG recommended a reduction in the indirect rate.

4) Project Name: RSVP COVID-19 Cleaning and Sanitation

Agency: Nevada Rural Counties RSVP Program, Inc. (RSVP)

Funding Request: \$19,228
Recommendation: \$9,028
Applicant Score: 70%

Objective: Serving low to moderate income (LMI) persons.

Description: RSVP is requesting funding for cleaning the interior for all RSVP vehicles that transport clients, professional cleaning and disinfection for the RSVP office, and 10% of the Operations Manager salary for cleaning oversight.

Funding Recommendation Rationale: Approved under Section 105(a)(8) of the Housing and Community Development Act of 1974 (HCDA), provisions of public services. The ARWG is recommending partial funding based on the amount of money received for CDBG-CV. The ARWG is recommending funding for professional and interior vehicle cleaning. The ARWG is not recommending funding for the Fiscal Operations Manager and office cleaning because these costs are part of the RSVP budget and the application did not justify or explain otherwise.

Potential Additional Funding Available:

No additional funding is expected from the Nevada Governor's Office of Economic Development, at this time.

Eligibility Requirement

In order to be eligible for funding, every CDBG-funded activity (excluding planning and administration) *must* qualify as meeting one of the three national objectives of the program:

- Benefiting low- and moderate-income (LMI) persons or a low-income area,
- Preventing or eliminating slums or blight, or
- Meeting an urgent community development need due to threat to community health and welfare (e.g., natural disaster emergencies).

Past CDBG public facility and public service projects in Carson City have met the LMI criteria. This

means projects that get funded qualify by either:

- 1. Limited Clientele criteria: Serving persons where at least 51% of the clientele are LMI persons (senior citizens are also classified as LMI under this category); or
- 2. Area Benefit criteria: Meeting the needs within a service area where at least 51% of the residents in that area are LMI persons. (HUD provides data on the percentage of LMI persons within the Census Block Groups.)

It is very important that the program or project staff document the number of LMI persons served for grant monitoring and audit purposes.

Eligible Activities

Eligible activities for the use of CDBG-CV funds and examples of such activities include:
