### To All Nevada State, County and Local Representatives,

The purpose of this letter is to advise you of the following steps and direction that We The People of Nevada are taking regarding the Non-Pandemic Covid-19. First, there are two major points of concern that exist statewide that are dangerously impacting every citizen regarding this 'influenza'.

## THE GOVERNOR CANNOT MANDATE ANYTHING AND THERE IS NO STATE OF EMERGENCY!

Title 18 U.S. Code § 1038. False information and hoaxes (a) Criminal Violation.

Last week there was a comment that some of the people here don't even have kids in the district. My daughter would still be in the district had this nonsense not happened. We're here for the children, parents and teachers that can't be here or don't want to come for fear of retaliation. I don't envy the job you have to do That being said I hope you make your decisions based on parents and employees choice. Let them choose what they want to do with their body.

I noticed that this time last year it was almost impossible to get a Covid test now this year we are testing more people regardless if they have symptoms or not. To whom it concerns,

Because if you don't, you are in violation of Section 242 of the U.S. Code § Title 18 Deprivation of rights under color of law, which states...

Whoever, under color of any law, statute, ordinance, regulation, or custom, willfully subjects any person in any State, Territory, Commonwealth, Possession, or District to the deprivation of any rights, privileges, or immunities secured or protected by the Constitution or laws of the United States, or to different punishments, pains, or penalties, on account of such person being an alien, or by reason of his color, or race, than are prescribed for the punishment of citizens, shall be fined under this title or imprisoned not more than one year, or both.
