Staff Summary: Several properties acquired by the Open Space Division of the Carson City Department of Parks, Recreation and Open Space do not have official names. Working with the Washoe Tribe of Nevada and California, nominations were provided for six properties throughout Carson City that hold cultural significance for the Washoe Tribe. An online survey was made available to the public to vote on the names or provide

additional recommendations. The results were reviewed at the OSAC meeting on April 19, 2021, and OSAC provided recommendations to the Board of Supervisors for final approval.

February 25, 2019 – OSAC heard a presentation from the Washoe Tribe of Nevada and California regarding proposed nominations for the naming of six Open Space properties throughout Carson City.

February 26, 2018 - OSAC considered two agenda items for the naming of open space acquisitions located in the Kings Canyon area. OSAC moved 7-0 to table this discussion until further input was received from the Washoe Tribe.

Background/Issues & Analysis

On April 19, 2021, at its regularly scheduled meeting, OSAC took action to recommend to the Board of Supervisors that six unnamed Open Space properties be named as: (1) Vidler Open Space; (2) Washoe Wetlands Open Space; (3) Gumalonga Open Space; (4) Voltaire Canyon Open Space; (5) Tahnu Leweh Open

Space; and (6) Dasolung Ridge Open Space	e. Attached is the meeting	staff report with details	on the public



Staff Summary: Several properties acquired by the Open Space Division do not yet have official names. Working with the Washoe Tribe of Nevada and California, nominations were provided for six properties throughout Carson City that hold cultural significance to the Washoe Tribe. An online survey outlining the background, location and proposed nominations was available on the Carson City Parks, Recreation & Open Space Department website for two weeks to receive input and votes from the public. The results of that survey are outlined below.

Previous Action

February 25, 2019 – the Open Space Advisory Committee ("Committee") heard a presentation from the Washoe Tribe of Nevada and California regarding proposed nominations for the naming of six Open Space properties throughout Carson City.

February 26, 2018 - the Committee considered two agenda items for the naming of open space acquisitions located in the Kings Canyon area. The Committee moved 7-0 to table this discussion until further input was received from the Washoe Tribe.

Background/Issues & Analysis

In February 2018, two properties in Kings Canyon went before the Open Space Advisory Committee to review naming nominations from the public. At that time, one nominating party suggested names to

recognize and honor the Native American culture in our area. Policy #2 in the "Resolution Establishing Policies and Procedures for the Naming of Open Space Properties Within Carson City" suggests, "if possible, names should be related to the unique natural landscape, geographic or topographic features, indigenous plants or wildlife, cultural or historical heritage." As a result, Mr. Darrel Cruz, Director of the Tribal Historic Preservation Office with the Washoe Tribe was contacted to provide nominations for several properties throughout Carson City. Mr. Cruz was provided a map and generally asked to suggest names on properties that may have been important or significant to the Tribe. Mr. Cruz responded with proposed names for six properties. See attachments for more details and locations.

The list of proposed names, in order of property, include:

- 1. Tusha Aushgu Open Space 64%
- 2. Washo Detevah Open Space 62%
- 3. Gumalonga Trail Open Space 66%
- 4. Mutzook Leweh Open Space 58%
- 5. Tahnu Leweh Open Space 64%
- 6. Dasolung Ridge Open Space 68%
- Other (see attached comments and recommendations)
- No comment 3%

The public was notified via a press release, the Carson City Parks, Recreation & Open Space Department website and Facebook page, and other local media outlets of the opportunity to vote. There was a total of 50 people who responded to the survey. Several participants added comments and provided alternative names for consideration. Some suggestions, if not selected at this time, may be added to the next survey for the naming of other properties within the vicinity. After the Committee takes action to name the property, staff will forward that recommendation to the Board of Supervisors for their consideration.







March 31, 2021

Residents are invited to participate in a survey for the official naming of six properties acquired by the Carson City Open Space Program. The subject properties are located throughout Carson City. Please refer to the map for each property location.

The policies for the naming of properties acquired by the Open Space Program were adopted by the Carson City Board of Supervisors as Resolution No. 2013-R-19. Notable policies include:

- 1. Official names should provide some form of individual identity to the property or specific part of any owned property.
- 2. If possible, names should be related to the unique natural landscape, geographic or topographic features, indigenous plants, or wildlife, cultural or historical heritage.
- 3. The naming for individuals and/or families should be reserved as an incentive towards significant donations of land and/or endowments. It is encouraged that any recommended name be designated posthumously.

The Washoe Tribe of Nevada and California was invited to review a map of existing properties and provide naming suggestions for properties and places in Carson City that are important to their culture and history. With their participation and the potential adoption of official names, we will be able to better recognize and celebrate the history of the Washoe Tribe throughout our region.

The deadline for participation is **April 12, 2021**. The survey results and recommendations will be discussed with the Open Space Advisory Committee meeting on **April 19, 2021**.

Map Reference #: 1

- General Location: Located to the north of Riverview Park and south of the Empire Ranch Golf Course.
- <u>History:</u> These 38.96 acres were donated to Carson City from Vidler Water Company in 2010 to protect Carson River floodplain and riparian habitat, as well as to allow for passive recreation.
- Existing access and uses: The property can be accessed by a trail that connects Riverview Park through the referenced property as you travel north to connect to the Empire Ranch Trail. The property and associated trail can be enjoyed by hikers, bicyclists, and equestrians.
- Recommendation:

- <u>General Location:</u> Located to the west of Lompa Lane, behind St. Teresa Of Avila Catholic Community.
- <u>History:</u> These 17.62 acres were donated to Carson City in 2001 to protect important wetland habitat in Eagle Valley.
- Existing access and uses: The property can be accessed to the east off Goni Road. It serves as one of the last remaining pockets of wetlands in Carson City and provides important wildlife habitat. There are no trails present on the property at this time.
- Recommendation:
 - o Washo Deteyeh Open Space (Washoe Tribe nomination meaning "Washo Place Live There")

Map Reference #: 3

- General Location: Located around the west side of Lakeview Park and the Lakeview Subdivision.
- <u>History:</u> These 320 acres were conveyed from the U.S. Forest Service to Carson City per the Omnibus Public Land Management Act of 2009 to protect and manage as a natural area.
- Existing access and uses: There is limited parking available on the east end of Hobart Road. The double-track road/trail to Hobart Reservoir and Secret Trail travel through this property.
- Recommendation:
 - Gumalonga Trail Open Space (Washoe Tribe nomination meaning "A Leader of the Washoe Tribe"). The Gumalonga Trail was a route used by the Washoe people to travel between what are now known as Eagle Valley and Washoe Valley.

- General Location: Located south of Voltaire Canyon Road and north of Highway-50.
- <u>History:</u> These 258.59 acres were conveyed from the U.S. Forest Service to Carson City per the Omnibus Public Land Management Act of 2009 to protect and manage as a natural area.
- Existing access and uses: The property can be accessed from Voltaire Canyon Road which provides access to U.S. Forest Service lands and can be used for passive and motorized recreation.
- Recommendation:

- <u>History:</u> These 374.91 acres were purchased in 2005 using Quality of Life Sales and Use Tax Funds and Nevada Division of State Lands, Conservation and Resource Protection Grant Program (Question 1) funds.
- Existing access and uses: Access is via Kings Canyon Road, approximately 3 miles from the Waterfall Trailhead.

- <u>General Location:</u> Located 2.8 miles due west of Carson City. The property is bordered to the north, east, and west by U.S. Forest Service land and to the south by private property.
- <u>History:</u> These 40 acres were purchased in 2006 using Quality of Life Sales and Use Tax Funds and Nevada Division of State Lands, Conservation and Resource Protection Grant Program (Question 1) funds.
- Existing access and uses: Access is via Kings Canyon Road, approximately 2.2 miles from the Waterfall Trailhead. At this point the road splits with a dirt road leading to the left (or southwest) and the Old Lincoln Highway leading to the right (or west). Turn to the left onto a rough 4-wheel drive road that leads to the south. Take this road for approximately 0.6 miles to the top of the hill which is the northern portion of the property. The smaller dirt road rises 200 feet to the top of the hill and is loose with large rocks and tight turns. Parking and hiking access can be accommodated on the property in a small unvegetated flat area at the end of the road on the top of the hill.

RESOLUTION NO. 2013-R-19

A RESOLUTION ESTABLISHING POLICIES AND PROCEDURES FOR THE NAMING OF OPEN SPACE PROPERTIES WITHIN CARSON CITY

WHEREAS, the Open Space Program was created through a voter-approved ballot initiative in 1996, often referred to as Question 18; and

WHEREAS, Carson City Charter Provision 2.230 empowers the Board of Supervisors to regulate public parks, buildings, grounds and rights-of-way within the City; and

WHEREAS, Carson City Charter Provision 8A.030 defines open space as real property that is undeveloped or partially developed natural landscape, including, but not limited to, ridges, stream corridors, natural shorelines, scenic areas, watershed areas, viewsheds, agricultural or other land devoted exclusively to open-space use, conservation easements and easements devoted or connecting to open-space use; and

WHEREAS, the Board of Supervisors desires to establish policies and procedures for the naming of the open space properties within Carson City;

NOW, THEREFORE, this Board hereby resolves to adopt the following:

POLICIES

- 1. Names should provide some form of individual identity to the property or specific part of any owned property.
- 2. If possible, names should be related to the unique natural landscape, geographic or topographic features, indigenous plants or wildlife, cultural or historical heritage.
- 3. The naming for individuals and/or families should be reserved as an incentive towards significant donations of land and/or endowments. It is encouraged that any recommended name be designated posthumously.
- 4. Individuals and organizations should be encouraged to submit nominations to the Parks and Recreation Department.
- 5. Due to their familiarity with the individual properties, committee members and staff may submit nominations.

PROCEDURES

- 1. After the City has acquired title to the property, the Parks and Recreation Department is responsible to solicit nominations.
- 2. The Parks and Recreation Department will publicize the open period including the deadline for nominations.
- 3. A formal nomination and justification must be submitted, in writing, to the Parks and Recreation Department.
- 4. The Parks and Recreation Department staff will review and research the nomination(s). Staff will prepare a written summary for the Open Space Advisory Committee (OSAC).
- 5. The Open Space Advisory Committee will review the nomination(s) for consideration at a regularly scheduled meeting. Upon OSAC recommendation, Parks and Recreation Department staff will forward to the Board of Supervisors for approval.
- 6. Upon Board of Supervisors' approval, the name shall be identified on open space signage and materials.

Upon motion by Supervisor John McKenna, seconded by Supervisor Brad Bonkowski, the foregoing resolution was passed and adopted this 2nd day of May, 2013, by the following vote:
