Human Services

- Two households, which were homeless, were rehoused through the Emergency Solutions Grant-Rapid Rehousing grant.
- Ten individuals were housed through CCSHARES, which is the housing partnership between CCHHS and the Carson City Specialty Courts.
- Six households impacted by COVID were assisted with rental assistance with the COVID Emergency Solutions Grant.
- Twelve requests were made by the COVID Investigation Team for wrap around services for quarantined residents due to COVID. These requests were followed up on by Case Managers.
- Three residents were housed in a location secured by CCHHS who did not have a place to isolate or quarantine due to COVID.

Public Health Reaccreditation Efforts Update

- Documentation has been submitted to PHAB
- PHAB will review documentation and ask for clarification or more documentation

Public Health Emergency Preparation

- Completed Liaison Officer and Finance/Administration Unit Leader trainings
- Several CCHHS staff are scheduled to complete advanced emergency management classes to better prepare CCHHS staff to respond to future public health emergencies.
- On November 17, 2021, the Quad-County Healthcare Coalition received training regarding radiological emergencies and hosted the Region IX Assistant Secretary for Preparedness and Response Coordinator, Captain Kevin Sheehan (Dr. Lyons included information in her report).
- Originally set to be 58 flu vaccination events in October turned into 69 flu vaccination events across the Quad-County region. Most of these events were in collaboration with our schools in Carson City, Douglas County, and Lyon County. Several of the events were with community partners and employers as an exercise of our Points of Dispensing plans.

COVID Testing and Vaccination

- Vaccination events continue to be offered throughout the Quad-Counties region. Vaccinations
 include booster shots for Pfizer and Moderna as well as pediatric Pfizer doses. There has been an
 increase in vaccinations during the last 4 weeks due to booster shots being approved, pediatric
 vaccines being approved, and employer mandates going into effect. CCHHS continues to offer
 opportunities, not to mandate vaccines.
- CCHHS is no longer using the National Guard to assist with community-based events. All communitybased vaccination events offered in the Quad-Counties region are done so with CCHHS staff from the Public Health Preparedness program.
- CCHHS serves as a regional distributor for vaccines to healthcare providers registered with Nevada State Immunization Program. This allows providers to acquire smaller quantities of vaccine from CCHHS and to not have large amounts of vaccine waste. Health entities requesting through CCHHS include local provider offices as well as worksite health programs.
- Community-based testing and testing at CCHHS will be suspended at the end of November due to a lack of demand. There are several entities within the community that offer testing and these entities have a much higher testing demand than CCHHS. If there is an increased demand for testing in the community due to a new variant or increase in cases, CCHHS will evaluate offering symptomatic testing services again.
- CCHHS is recruiting local community partners to get signed up as a testing location through the State of Nevada. Once signed up, these community partners can offer free testing and analyses to the Community. This is available because Carson City's social vulnerability index value puts Carson at a level that allows the federal government to pay for these testing services. There are 2-3 providers who will begin offering testing sometime in January 2022.
- The Quad-Counties COVID Hotline helps individuals get connected with testing services in the area including the Community Health Nurse's Offices and local pharmacies. Additionally, the Hotline helps community members locate vaccine locations if the community member is unable to attend one of the community events or get to CCHHS for services.
- CCHHS continues to collaborate with Immunize NV to saturate the community with vaccination opportunities.
- CCHHS is serving the homebound and jail populations throughout the Quad-Counties region and works closely with employers and healthcare partners to offer vaccination events.

Tuberculosis (TB) Screening -

Individuals are screened at both onsite and offsite facilities. A TB test is a twovisit process. One visit to place the test and the second visit to assess the results. Some individuals are required to have two tests within 7 to 21 days of each other which then would require 4 visits to complete both rounds of testing. TB testing is included in the services provided at the clinic as well as an inpatient drug treatment center.


Adolescent Health Education

- In September 2021, two Sexual Risk Avoidance Education (SRAE) classes were conducted -One class at the Carson City Community Center with 2 students; and Virginia City Middle School with 18 students.
- In October 2021, one Personal Responsibility Education Program (PREP) class was conducted at Western NV Rural Youth Center 7 individuals attended.
- Staff are seeking training and updated materials to be able to offer Families Talking Together Training, dates are still to be determined. Families Talking Together is a parentbased intervention to prevent and/or reduce sexual risk behavior among adolescents. The main components of the intervention are parent discussions with an interventionist and a family workbook designed to teach parents effective communication skills, build parentadolescent relationships, help parents develop successful monitoring strategies, and teach adolescents assertiveness and refusal skills. The program can be delivered to parents either individually or in small group sessions, in a range of settings.

*Both the SRAE and PREP courses consist of 8 one-hour modules. The classes facilitated at the youth correction facilities see youth transitioning in and out of the facilities. They may be able to go home during the time we are facilitating the course or are entering the facility during our time with them. Hence, the fluctuation in the numbers at the facilities.

Tobacco Control and Prevention


- CCHHS' Tobacco program staff continues to participate in Nevada Tobacco Prevention Coalition as members.
 - Monitoring meetings regarding Cannabis Advisory Commission recommendations for the Cannabis Compliance Board.
- CCHHS' Tobacco program staff is working to finalize a smoke-free toolkit for multi-unit housing Owners/Property Managers.
 - Assisting local multi-unit property, Carson Hills, to go smoke-free, includes 370 units.
- Participating on WNC Healthy Campus committee
 - Assisting with strengthening WNC's tobacco policy; will be surveying campus /educating students about policy, providing additional signage (poster for bathroom stalls), and possible discussion of installing vape monitors for campus bathrooms.
- Reaching out to Behavioral Health Facilities inquiring about being tobacco-free campus.

Chronic Disease Division Quality Improvement (QI) project – Branding and Video Chronic Disease Prevention & Health Promotion (CDPHP) Division's programs have identified a barrier with how services are promoted and offered as part of CCHHS due to COVID. The goal of this project is to gain recognition for the Division which will allow programs within the division to be highlighted.

• A logo was developed for identification.



- The design was pulled from the CCHHS' logo with the mountain design, triangles were used to represent mountains but also to represent a modular vision of each division connected in similar shape but differentiated in colors.
- The Chronic Disease Prevention & Health Promotion (CDPHP) Division selected a logo that was green to grey scale, with CCHHS identified at the top and programs within the CDPHP Division listed at the bottom (tobacco, adolescent health, diabetes, and Ryan White program). This offers more immediate recognition through the connection to CCHHS at the top and requires less branding awareness and promotion on behalf of CDPHP division.
- It's a new combined logo which is important for identification and to communicate to the public the identity of the CDPHP Division as a collective group.

- An animated outreach video was developed to highlight CDPHPs' four programs: Tobacco, Adolescent Health, Diabetes and Ryan White Program. The video has currently been disseminated through the CCHHS CDPHP webpage, CCHHS lobby and social media (Facebook and YouTube). Video length is about 2 minutes.

Activities


- Hosted a multi-county housing meeting in attendance was Lyon County, Churchill County, Storey County, Douglas County, and Carson City.
- Submitted Organizational Standards Survey, standards are reviewed each year for compliance as a Community Action Agency and in relation to the Community Services Block Grant.

 Human Services Division staff participates in the Carson City Behavioral Health Taskforce, Carson City Community Coalition, Rural Nevada Continuum of Care (RNCOC), RNCOC Coordinated Entry (intake assessments of the homeless), Nevada Community Action Association, Nevada Association of County Human Services Administrators, and Carson City Forensic Assessment Services Triage Team (FASTT). In addition, Human Services is a resource hand off for the Carson City Specialty Courts, Mobile Outreach Safety Team (MOST), and discharge planners for the hospital.


Individuals Assisted

Previous report included the month of June 2021; this and future reports will reflect an accumulation of the current fiscal year.

• Between July 1 to Oct 30 - Received 91 new applications and another 164 returning applicants (numbers are unduplicated). Chart indicates total received previous fiscal year and currently received this fiscal year.



- On-going housing program (Shelter Plus Care) 7 households that were previously chronically homeless individuals.
- 11 households in Homeless Prevention programs through the Emergency Solutions Grant-Homeless Prevention and Affordable Housing Tax Fund.
- 2 households which were homeless and were rehoused through the Emergency Solutions Grant-Rapid Rehousing grant.
- 10 individuals were assisted with security deposits through the Welfare Set-Aside funds.
- 5 one-time rental assistance through the Welfare Set-Aside funds.
- 10 in CCSHARES which is the housing partnership with the Carson City Specialty Courts.
- 1 senior rent supplement with the Indigent Accident Refund funds.
- 6 households impacted by COVID were assisted with rental assistance with the Emergency Solutions Grant COVID.
- 98 inmates were enrolled in FASTT.
- 12 requests for wrap around services for quarantined residents due to COVID.
- 3 residents were housed in a location secured by CCHHS who did not have a place to isolate or quarantine due to COVID.
- 12 indigent cremation assistance ---The payment amount increased from \$550 to \$650 in August 2020.



- 3 individuals in the county only assistance for long term care; 2 are deceased and currently one continues to receive assistance.
- 111 individuals (average) in Medicaid County Match program (long term care) -- State of Nevada is not currently invoicing counties until the County Match contract is executed. Contract has not been distributed to the counties.


WIC Statistics

WIC encourages breastfeeding and monitors length of time participants breastfed. WIC was given flexibility and did not have to require in person appointments during the COVID-19 pandemic. This challenged the WIC staff to keep motivating and supporting participants in their choice to breastfeed. During the grant year 10/1/2020 to 9/30/2021:

- Gardnerville Clinic: Reported a 14% increase with 6 months breastfeeding; a 4% increase with 9 months breastfeeding; and a 21% increase with 12 months breastfeeding.
- Carson City Clinic: Reported a decrease in 6 months and 9 months and a 4% increase in breastfeeding for 12 months.

Sexual Assault Response Team

• 69 new applications for sexual assault funds in 2021; 3 of those are actively receiving counseling



- Six sexual assault exams conducted calendar year to date.
- No exams were conducted in Reno.

Quad-County PHP staff have completed Liaison Officer and Finance/Administration Unit Leader trainings. Several CCHHS staff are scheduled to complete advanced emergency management classes to better prepare the Agency to respond to future public health emergencies.

Heath Care Emergency & Disaster Preparation -

- The Quad-County Healthcare Coalition has been active throughout the COVID-19 response.
- Several Quad-County Healthcare Coalition members from community-partner agencies are attending the National Healthcare Coalition Conference in Orlando, FL the week of November 29-December 3. Lessons learned and resources identified will be brought back to strengthen the regional Coalition.
- On November 17, 2021, the Quad-County Healthcare Coalition received training regarding radiological emergencies and hosted the Region IX Assistant Secretary for Preparedness and Response Coordinator, Captain Kevin Sheehan.
- The Coalition conducted an After Action Review for the Caldor Fire response.
- The Quad-County PHP team continues to be actively engaged with local healthcare partners in response to the staffing shortages that most hospitals are experiencing across the country.

Community Vaccinations

• Originally set to be 58 flu vaccination events in October turned into 69 flu vaccination events across the Quad-county region. Most of these events were in collaboration with our schools in Carson City, Douglas County, and Lyon County. Several of the events were with community partners and employers as an exercise of our Points of Dispensing plans.

• Continuing to host COVID-19 vaccination events every week. Have plan ready to support any changes in COVID vaccination recommendations.
