adjust the Secured and Unsecured Tax Rolls for Fiscal Year ("FY") 2020/2021 per NRS 361.765 to 361.768, inclusive, on multiple properties resulting in a reduction of \$9,108.40 from the Secured Tax Roll and an addition of \$88,814 to the Unsecured Tax Roll, and whether to authorize the Carson City Treasurer to refund any overassessments/penalties in the amount of \$368.93, remove unsecured tax penalties due to billing errors in the

amount of \$19,685.72 and collect additional taxes due. (Andrew Rasor,

Staff Summary: State law requires the Board of Supervisors ("Board") to review a report of clerical, typographical or factual errors on the tax rolls and if the Board is satisfied with the report, to order the Treasurer to make any corrections to the tax rolls and collect underassessments and refund any overassessments. This item includes a report on clerical, typographical and factual errors from the FY 2020/2021 Secured and Unsecured

Tax Rolls for possible correction and adjustment by the Board.

I move to authorize the corrections and adjustments to the Fiscal Year 2020/2021 Secured and Unsecured Tax Rolls as presented and to direct the Carson City Treasurer to collect any monies due and to refund or credit any overassessments.

Background/Issues & Analysis

Carson City updated the software used for property tax assessments. The transition and conversion from one tax calculation software program to another, along with adjustments to the taxable values, improvement values, and exemptions for certain accounts, requires adjustments to numerous parcels of real property, personal property and business accounts in Carson City. The supporting materials provide a list of the impacted property accounts and the reasons for corrections or adjustments.

These corrections and adjustments reflect differences in the tax calculation process between the previous and current software programs used by Carson City. It also includes the tracking of solar energy values in the current tax calculation software program which was previously not available under the old software program. The list includes corrections and adjustments made due to tax calculation differences between the previous

and current tax calculation software programs for the prior year gross assessed values (PYGAV), taxable values, improvement values and exemptions for certain accounts; the removal of penalties for some commercial business accounts that did not receive a tax bill; the required refund of penalties for some commercial business accounts that did not receive a tax bill; and the removal of taxes applied to certain inactive parcels or common area parcels that should not have received a bill.
