Ray has been with CCDPW for a little less than three years. In that time, he has been incredibly dependable, rarely taking time off from work. I work with Ray daily and he has some of the best work ethic I've seen in my 30+ years in the workforce. No matter how the days is going, he maintains a great attitude and a sense of humor, all while demonstrating leadership qualities.

He is highly regarded by his colleagues in Control Systems, Water Production and Wastewater for the service he provides. I've personally learned invaluable skills from Ray, which have helped me become more efficient in my everyday duties.

His most recent success was a project at the Wastewater plant which due to its size, would typically have gone out to bid to a contractor/integrator. Despite the intimidating complexity of this project, he accepted the challenge. He developed a plan, procured supplies, installed new electrical conduit/wiring, researched a control strategy, and programmed the logic controller (PLC). He also repurposed an expensive electrical cabinet that was destined for the landfill. Using his vision and innovation during this project, the decades old technology was upgraded to state-of-the-art controls. He was dedicated to this project and worked tirelessly to complete it. After a little over one year, he completed the project and conducted a training class for the wastewater operators and mechanics to bring them up to speed on the new technology.

It's estimated that by keeping this project in-house, Ray saved the city hundreds of thousands of dollars.

Ray Murray has been the driving force behind the integration of instrumentation and the modernization of controls for the WRRF's Diffused Air Flotation (DAF) Thickener process area. Originally built in 1984, the DAF Process instrumentation and controls have exceeded its useful lifespan.

Using ingenuity, Ray re-purposed an entire Programmable Automation Controller (PAC) enclosure that was installed in the Headworks process area during WRRF Phase 1A Improvements and subsequently removed from Headworks during WRRF Phase 1B Improvements. A PAC is a computer that interfaces field wiring and, depending on the program stored in them, will turn on or off pumps, generate alarms, display levels, flows, or pressure values. The PAC also interfaces the Supervisory Control and Data Acquisition (SCADA) System so the Wastewater Operator can visualize the process remotely by a desktop computer or iPad. Ray installed the PAC enclosure in the DAF Process Area, this enclosure alone is estimated to cost \$75,000.

Ray reverse engineered the old controller program, reviewed old drawings, and sifted thru old Operations and Maintenance (O&M) manuals to create updated logic in the new PAC, incorporating all the coding for the latest control, status, and operator alarms. He also installed and programmed a local operator display so Wastewater operations staff can control the entire process locally.

Ray installed new level instruments, control sensors, analog speed control and reference sensors and wired them all to the new PAC enclosure for automation of the process. Ray added multiple conduits to the PAC Enclosure to re-route the existing input/output (I/O) and control wiring.

Ray was also instrumental in the cutover process to the new PAC, he spear-headed the Controls team in moving all the field wiring over from the antiquated old controls to the new PAC, testing and verifying operation of signals, alarms, and controls.

I estimate that Ray has saved the City in excess of \$200,000 by completing this monumental project in-house. Ray's tenacity and dedication to job completion are unparalleled. The City is extremely lucky to have Ray.
