15 **ADMINISTRATIVE ORDER**

16 WHEREAS, the First Judicial District Court and the Carson City Justice/Municipal
17 Court, hereafter referred to as "Courts," filed an Administrative Order #14OP000011B on
18 March 29, 2014 setting forth the Salary Schedule and Benefits for the Classified Court
19 employees.

20 WHEREAS, on July 13, 2015, the Courts filed an amended Administrative Order
21 #15OP000011B establishing the merit ratings for the Classified Court employees;

22 WHEREAS, the Courts have reviewed the contract between Carson City and the
23 Carson City Employee Association approved by the Carson City Board of Supervisors on
24 December 2, 2021;

25 WHEREAS, the Courts have determined that adjustments to the Court Classified
26 employees' compensation and benefits are reasonable and necessary to be consistent with

1 the approved contract and to ensure employees are compensated equitably and receive the
2 same benefits as Carson City Classified employees;


3 IT IS ORDERED that the Administrative Order #15OP000011B filed on July 13, 2015,
4 establishing the merit ratings for the Classified Court employees is hereby rescinded.


5 IT IS FURTHER ORDERED that all other provisions of the Administrative Order
6 #14OP000011B filed on March 29, 2014 are to remain in full force and effect, save and
7 except, any provisions modified by Carson City and the Carson City Employee Association
8 contract approved by the Carson City Board of Supervisors on December 2, 2021, as
9 related to salaries and benefits or until further order of the Courts;

11 IT IS FURTHER ORDERED that the Courts maintain their management rights for
12 Court Classified employees and as a separate branch of government.


13 IT IS FURTHER ORDERED that the Administrative Order shall be filed with the First
14 Judicial District Court Clerk's Office and copies disseminated by the Clerk to the Carson City
15 Manager's Office, Carson City Human Resources, Carson City Finance Department, and
16 the Carson City District Attorney's Office.
