**ADMINISTRATIVE ORDER**

The Administrative Orders filed on March 20, 2020, March 16, 2020, in case # 20 OP 00001 1B, and on May 13, 2021, in case # 21 OP 00001 1B are hereby modified.

On February 10, 2022, Governor Stephen Sisolak lifted the mask mandate for the State of Nevada effectively immediately. His decision was based on declining Covid-19 and related variants' infectious rates and hospitalizations.

NOW THEREFORE, IT IS HEREBY ORDERED effective February 10, 2022, the First Judicial District Court and the Carson City Justice/Municipal Court will no longer require masks or facial coverings to be worn in the Carson City Courthouse and Juvenile Court. To continue to minimize the risk of COVID-19 and/or variant spread, complimentary masks will still be provided and are optional to be worn by the public and/or employees.


1 IT IS FURTHER ORDERED that the Administrative Orders filed on March 20, 2020,

3 1B are to remain in full force and effect until modified or rescinded by a subsequent order.


4 IT IS FURTHER ORDERED that the First Judicial District Court Clerk's Office


