I have raised three daughters in the 4H/FFA programs. My middle daughter turned her FFA project into a small business raising show and market hogs. For the first 6 years of her project, she was able to raise and sell enough hogs to not only pay for their own feed, but they paid for the feed for the rest of our animals for the entire year! For the last 3 years, it has been impossible to get into the USDA facilities in the area to get the hogs processed. Sales were lost because we were not able to meet the customer request of USDA approved processing. Thank goodness for mobile processors because without them, we wouldn't have anywhere else to go. Recently, I tried to get into Wolf Pack Meats with three hogs...they said they couldn't even try to get them in. The mobile processor is booked for weeks and we are now going to lose money on the hogs we have worked so hard to raise.

PLEASE do not delay the approval of the Carson Valley Meats facility. It is vital to not only the FFA/4H/Grange projects for our kids but also for the small producers that want to re-connect people with where their food comes from.
