Agenda Title: For Possible Action: Discussion and possible action regarding the appointment of

members to one committee to prepare arguments in favor of, and a second committee to prepare arguments in opposition to, the approval of a ballot question to be included on the November 2022 general election ballot asking whether to continue the current imposition of a five-cent excise tax on diesel fuel sold in Carson City which is set to expire on December

Staff Summary: NRS 295.121 requires the Board of Supervisors to appoint separate committees to prepare arguments advocating for and opposing approval of ballot questions. The Carson City Clerk-Recorder's Office has received an application from Jim Dodson to serve on the committee advocating for approval of the ballot question, and an application from Chris Harris to serve on the committee opposing approval of the ballot

question.

Previous Action

June 4, 2020 - the Board of Supervisors adopted Ordinance No. 2020-7 to impose a five-cent per gallon diesel fuel tax with a provision for the tax to expire by limitation on December 31, 2022, unless the expiration is removed by approval of the voters at the next general election.

Background/Issues & Analysis

On June 4, 2020, the Board of Supervisors adopted Ordinance No. 2020-7, now codified at section 21.05.020 of the Carson City Municipal Code ("CCMC"), to impose a five-cent per gallon diesel fuel tax. This excise tax is for the sole purpose of construction, maintenance or repair of public highways, roads, streets and alleys, other than those maintained by the federal government and the State of Nevada. The tax became effective on August 1, 2020, but is subject to a sunset provision providing for the tax to expire on December 31, 2022, unless Carson City voters approve a ballot question allowing the tax to continue.

NRS 295.121(5) requires the Carson City Clerk-Recorder to recommend persons to the Board of Supervisors for appointment to committees to prepare arguments advocating for and opposing the ballot question. Each committee must be composed of three members who favor approval and three people who oppose approval. If the Board of Supervisors is unable to appoint three members to each committee, the Board of Supervisors may appoint fewer than three, but must appoint at least one person to each committee. If the Board of Supervisors is unable to appoint at least one member to each committee, the Clerk-Recorder must prepare the arguments in consultation with the District Attorney's Office.

MEMORANDUM REGARDING BALLOT QUESTION COMMITTEES

In compliance with Nevada Revised Statute ("NRS") 295.121, the Carson City Clerk-Recorder ("Clerk") is beginning the process of forming two ballot question committees (hereafter referred to as "Committees") for the November 8, 2022 General Election. The purpose of the Committees is to draft arguments for and against a ballot question on whether to continue a diesel fuel tax to be used for the sole purpose of construction, maintenance and repair of public roads and streets in Carson City.

In compliance with NRS 295.121 the official advertisement for these Committees shall commence on Wednesday, March 9, 2022. The last day to submit a Ballot Question Committee Interest Form ("Interest Form") to the Clerk will be no later than 5:00 p.m. on Wednesday, March 30, 2022.

In an effort to provide as much information as possible to all interested persons please find attached a ballot question information packet which will provide you with an Interest Form, copy of the public notice for recruitment, copy of NRS 295.121, a schedule for preparation of the ballot question and rules regarding the Committees.

After the deadline to receive Interest Forms has passed, the Clerk will submit a recommendation to the Carson City Board of Supervisors regarding the membership of these Committees. The Committees are not required to comply with the Nevada Open Meeting Law but may seek and consider comments from the public. The Committees shall meet and prepare a written argument advocating or opposing the question for inclusion on the ballot.

The Committees will have until Friday, May 20, 2022, by 5:00 p.m. to prepare and submit the arguments to the Clerk. The Clerk will then forward the arguments to the opposite Committee on Monday, May 24, 2022. The Committees shall prepare a rebuttal to the argument prepared by the other Committee and submit it to the Clerk by 5:00 p.m. on Friday, July 1, 2022. If a Committee fails to submit either the argument, rebuttal or both, the Clerk will place the following language on the sample ballot: "Argument (advocating)/(opposing) question not submitted by Ballot Question Committee." or "Rebuttal to argument (advocating)/(opposing) question not submitted by Ballot Question Committee."

I have an interest in supporting this ballot question because I see it as an equitable way to help fund much needed repairs, restoration, and improvements to the local road system. Currently there is a huge shortfall of revenue compared to needs. I have a background in transportation engineering and currently serve as a member of CAMPO and Carson City RTC boards which gives me insight to these needs. Passage of this question would allow collection of revenue from diesel fuel purchased in Carson City to be used on local roads. If this ballot question isn't passed, diesel fuel users will no longer pay any fuel tax to fund local road needs. Most diesel fueled vehicles are heavier than gasoline fueled vehicles and consequently do more damage to roads and highways.

CARSON CITY RULES FOR FORMATION OF A COMMITTEE TO PREPARE ARGUMENTS ADVOCATING AND OPPOSING APPROVAL OF BALLOT QUESTIONS; DUTIES AND RULES GOVERNING COMMITTEE; REVIEW OF ARGUMENTS; AND PLACEMENT OF ARGUMENTS IN SAMPLE BALLOTS

In accordance with Nevada Revised Statutes ("NRS") 295.121, for each initiative, referendum, or other question to be placed on the ballot, the Carson City Board of Supervisors shall, in consultation with the Clerk-Recorder ("Clerk"), appoint two committees.

One committee must be composed of three persons who favor approval by the voters of the initiative, referendum, or other question. The second committee must be composed of three persons who oppose approval by the voters of the initiative, referendum, or other question. If the Board is unable to appoint three persons who are willing to serve on a committee, the Board may appoint fewer than three persons to that committee, but the Board must appoint at least one person to each committee.

A person may not serve simultaneously on both committees. If the Board of Supervisors fails to appoint a committee as required pursuant to NRS 295.121, the Clerk shall, in consultation with the District Attorney, prepare an argument advocating for approval and an argument opposing approval by the voters of the initiative, referendum or other question. Each argument prepared by the Clerk must satisfy the requirements of State Law. The Clerk shall not prepare the rebuttal of the arguments.

The committees shall:

- 1. Prepare arguments advocating or opposing approval of the ballot initiative, referendum or other question based on whether the members were appointed to advocate or oppose approval by the voters.
- 2. Prepare a rebuttal to the argument prepared by the other committee appointed.
- 3. Address in the argument and rebuttal:
 - a. The fiscal impact of the initiative, referendum or other question;
 - b. The environmental impact of the initiative, referendum, or other question; and
 - c. The impact of the initiative, referendum, or other question on the public health, safety, and welfare.

The Clerk shall set the dates that the arguments and rebuttals are to be submitted by the committees.

The following rules are set forth to comply with the above statute and will apply to initiatives, referendums, or other questions to be placed on the Carson City ballot by the Clerk:

- 1. The Clerk shall, in a newspaper having a general circulation in the county, cause a notice signed by the Clerk to be published advertising committee recruitment.
- 2. The Clerk shall provide an *Interest Form* and *Ballot Question Information Packet* to any person expressing interest in serving on a committee and any organization which has expressed interest in having one of its' members serve on a committee.
- 3. Completed *Interest Forms* shall be submitted to the Clerk by the date prescribed by the Clerk.
- 4. Following review of the *Interest Forms*, the Clerk shall recommend, at a regularly scheduled meeting of the Board of Supervisors, three persons who favor approval by the voters of the initiative, referendum, or other question and three persons who oppose approval by the voters of the initiative, referendum, or other question. If there are fewer than three persons that submitted *Interest Forms* for each committee, the Clerk shall recommend to the Board not less than one person for each committee. The Clerk shall make committee member recommendations based upon a review of the *Interest Forms*. The Clerk may consult with the District Attorney and/or any Carson City official with expertise in the subject area of the ballot question.
- 5. If the Board is unable to appoint three persons who are willing to serve on a committee, the Board may appoint fewer than three persons to that committee, but the Board must appoint at least one person to each committee. If the Board fails to appoint a committee; the Clerk shall, in consultation with the District Attorney, prepare an argument advocating approval by the voters and an argument opposing approval by the voters.
- 6. A person may not serve simultaneously on the committee that favors approval by the voters of an initiative, referendum or other question and the committee that opposes approval by the voters of that initiative, referendum, or other questions.
- 7. The term of office for each member commences upon his/her appointment and expires upon publication of the sample ballot containing the initiative, referendum, or other question.
- 8. Members serve without compensation.
- 9. A member may serve on more than one committee if there is more than one initiative, referendum, or other question.

- 10. A committee appointed pursuant to this method:
 - a. Shall select a chairman.
 - b. Shall seek and consider comments from the general public.
 - c. Shall prepare an argument either advocating or opposing approval by the voters of the initiative, referendum or other question limited to 400 words.
 - d. Shall prepare a rebuttal to the initiative, referendum or other question limited to 400 words.
 - e. Shall address in the argument and rebuttal:
 - i. The fiscal impact of the initiative, referendum or other question;
 - ii. The environmental impact of the initiative, referendum, or other question; and
 - iii. The impact of the initiative, referendum, or other question on the public health, safety, and welfare.
 - f. Shall not submit entire arguments or rebuttals in capital letters, indentations, stars, or bullets. Words that are underscored, capitalized or in bold face type will be set in italics <u>if appropriate</u>. Each argument and each rebuttal must be typed in a computerized format in paragraph form, preferable MS Word, and delivered to the Clerk on either a CD, a USB memory stick or by email. One printed, hard copy shall also be delivered as outlined in #11 below.
- 11. The arguments and rebuttals shall be submitted to the Clerk not later than 5:00 p.m. on the date prescribed by the Clerk. The Chairman of the committee shall attach a signed 'Argument/Rebuttal Cover Sheet' along with a printed copy of the Argument or Rebuttal statements with signature to indicate the committee has approved the text. Once the arguments and rebuttals have been submitted to the Clerk by the committee, they may not be amended or changed by the committee unless agreed upon by the committee, Clerk and District Attorney.
- 12. If a committee fails to submit the arguments and/or rebuttals by the time prescribed by the Clerk, the statement "Argument (advocating) (opposing) question not submitted by Ballot Question Committee." or "Rebuttal to argument (advocating) (opposing) question not submitted by Ballot Question Committee." as appropriate, will be printed in the sample ballot in place of the missing argument or rebuttal.

- 13. The Clerk will review the arguments and rebuttals submitted by the committees and reject any statements considered to be factually inaccurate, misleading, or libelous. The Clerk shall notify the committee chairman in writing that the arguments were accepted or if any statements were rejected. The decision of the Clerk is final for purposes of judicial review.
- 14. Not later than five days after notification that the Clerk has rejected a statement, the committee may appeal that rejection by filing a complaint in District Court. The Court shall set the matter for hearing not later than three days after the Complaint is filed and shall give priority to such a Complaint over all other matters pending the Court, except for criminal proceedings.
- 15. The Clerk shall place in the Sample Ballot, provided to the registered voters of the County, each argument and rebuttal prepared by the committees containing all statements not rejected as factually inaccurate, misleading, or libelous. Arguments and rebuttals shall be placed under the heading "Argument (Advocating)(Opposing) Question," and "Rebuttal to Argument (Advocating) (Opposing) Question". The words "Submitted by Ballot Question Committee (Advocating Approval) (Opposing Approval) of the Question as provided for in NRS 295.121" will appear at the end of each argument and rebuttal.
- 16. The Clerk may revise the language submitted by the committee so that it is clear, concise, and suitable for incorporation in the Sample Ballot. The Clerk will notify the chairman of the committee of any proposed revisions and shall not alter the meaning or effect of the committee's language without consent of the committee.

17. Word Count Standards:

- a. Names and titles of committee members preparing arguments are not counted.
- b. Punctuation is not counted.
- c. All geographical names shall be considered as one word; for example, "Humboldt County", shall be counted as one word.
- d. Each abbreviation for a word, phrase or expression shall be counted as one word; for example, "Misc." "Rd" shall be counted as one word.
- e. Hyphenated words that appear in any generally available dictionary shall be counted as one word. Each part of all other hyphenated words shall be counted as a separate word.

- f. Dates consisting of a combination of words and digits shall be counted as two words. Dates consisting only of a combination of digits shall be counted as one word.
- g. Any number consisting of a digit or digits shall be considered as one word. Any number that is spelled, such as "one," shall be considered as a separate word or words. "One" shall be counted as one word where "one hundred" shall be counted as two words. The following combinations are counted as one word: 2013, 25%, #5.
- h. Monetary amounts will be counted as one word; for example, "\$1,000,000" shall be counted as one word.
