For Possible Action: Discussion and possible action regarding an application for a Package Liquor License (LIQUOR-007041-2022) with Maboub Rehman as the liquor manager for The Country Store LLC located at 3389 Hwy 50 E, Carson City, NV 89701.

Recommendation: Approve the application for a Package Liquor License with Maboub Rehman as the liquor manager for The Country Store LLC at 3389 Hwy 50 E, Carson City, NV 89701 subject to the following approval:

- 1. The applicant must sign a sworn affidavit consistent with Carson City Municipal Code (CCMC) 4.13.060 regarding a server training course.
- 2. Alcohol sold must come from approved sources.
- 3. The owner of the liquor license must maintain on the premises, evidence of employee server training certification for all employees that serve or sell alcohol.
- 4. Approval is for packaged alcoholic beverages only.
- 5. No changes may take place without prior approval from health authority.
- 6. Adherence to the Food and Drug Administration Food Code and Nevada Administrative Code 446 for operational purposes.

Per Carson City Municipal (CCMC) 4.13, all liquor license requests are to be reviewed by the Hearings Officer. The Hearings Officer may grant or deny the application for a liquor license or place conditions on a license to ensure compliance with the Municipal Code.

The subject request is for The Country Store LLC to have a Package Liquor license with Maboub Rehman as the liquor manager. The liquor store will be located at 3389 Hwy 50 E, business license number BL-007039-2022.

The Sheriff's office will do an inspection around said location on 04/09/2022. The Sheriff's Office conducted a background check and did not find any disqualifying information based on CCMC 4.13.125.

This request has been reviewed by the Health Department. The Health Department inspected the premises and is recommending approval subject to the above conditions.

The Sheriff's Office has conducted a background investigation on the above applicant as the liquor manager for the Country Store.

- Background of premises: The Country Store is located at 3389 Highway 50 E and Mr. Maboub is applying as the new liquor manager for the location. The store is an existing business and has had various calls for service over the years for mostly for fraud, burglary and larceny.
- Financial arrangements: Mr. Rehman has invested \$150,000 of personal money for 50% ownership of the business. He indicated that it was a cash transaction and there are no terms. The seller, Obaid Mobaligh will retain 50% ownership.
- Method of operation: The Country Store is open daily and sells gasoline, groceries, snacks, beer, wine and hard liquor as well as general merchandise. The store has four employees and has a leased area for gaming machines. Mr. Rehman has been working at the store since 2018 he will continue work at the location full time. Per a management agreement, the seller Obaid Mobaligh will continue with responsibility as the liquor manager until Mr. Rehman's application has been approved.
- Results of background: The background for Maboub Rehman consisting of DMV records, local agency checks, Nevada criminal history query, credit report and fingerprint responses did not find any disqualifying information based on CCMC 4.13.125.
