AGENDA ITEM 4.B: For Possible Action: Discussion and possible action regarding an application for a Dining Room with Hard Liquor License (LIQUOR-006691-2021) with Lilia Godoy Cruz as the liquor manager for La Capital Café and Grill located at 1795 E College Parkway Suite 100, Carson City, NV 89706.

Recommendation: To approve an application for a Dining Room with Hard Liquor License with Lilia Godoy Cruz as the liquor manager for La Capital Café and Grill LLC at 1795 E College Parkway Suite 100, Carson City, NV 89706 subject to the following approval:

- 1. The applicant must sign a sworn affidavit consistent with Carson City Municipal Code (CCMC) 4.13.060 regarding a server training course.**
- 2. Alcohol sold must come from approved sources.**
- 3. The owner of the liquor license must maintain on the premises, evidence of employee server training certification for all employees that serve or sell alcohol.**
- 4. Changes to equipment or setup must be approved by health department.**
- 5. Adherence to the Food and Drug Administration Food Code and Nevada Administrative Code 446 for operational purposes.**

Per Carson City Municipal (CCMC) 4.13, all liquor license requests are to be reviewed by the Hearings Officer. The Hearings Officer may grant or deny the application for a liquor license or place conditions on a license to ensure compliance with the Municipal Code.

The subject request is for La Capital Café and Grill LLC to have a Dining Room with Hard Liquor license with Lilia Godoy Cruz as the liquor manager. The business is a full-service restaurant, that opened in March of 2022. The business is located at 1795 E College Parkway Suite 100, license number BL-006679-2021.

The Sheriff's office will do an inspection of said location on 4/5/2022. The Sheriff's Office did a background investigation and did not find any disqualifying information based on CCMC 4.13.125.

This request has been reviewed by the Health Department. The Health Department inspected the premises and is recommending approval subject to the above conditions.



The Sheriff's Office has conducted a background investigation on the above applicant as the liquor manager for La Capital Grill & Café.

- **Background of premises:** La Capital Café & Grill will be located at 1795 E. College Parkway Ste 100. The location was previously occupied by the Creekside Café which has been closed for business. La Capital Grill & Café is expected to open by mid-October.
- **Financial arrangements:** Lilia Cruz along with her husband and her brother in-law are investing \$60,000 to purchase the inventory and kitchen supplies from the previous owner. There will be a monthly lease of \$4000 paid to the property owners.
- **Method of operation:** La Capital Café & Grill will be open daily and will employ approximately fifteen employees. The café will serve Mexican-American food and sales of beer, wine, and hard liquor will be offered if approved for a license. Ms. Cruz is currently employed elsewhere and will be in the restaurant on a part time basis. She stated that she plans on transitioning into full time once the business takes off.
- **Results of background:** The background for Lilia Godoy Cruz, consisting of DMV records, local agency checks, Nevada criminal history query, credit report and fingerprint responses did not find any disqualifying information based on CCMC 4.13.125.
